


### Current Jail Inmate Age Distribution

This chart shows the age distribution of the current jail population in 5-year groupings.




### Current Inmates by Race

This chart shows the breakdown of the current inmate population by race.




### Current Jail Population by Sex

This chart shows the distribution in the number of current jail inmates by classification.



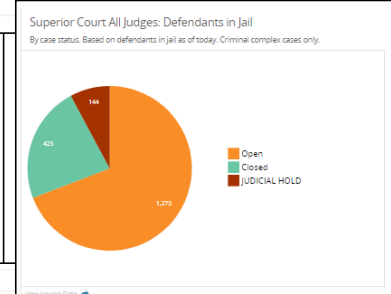
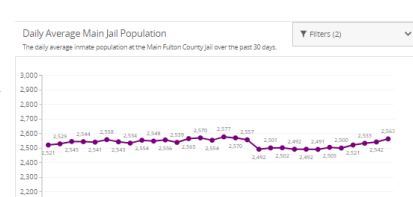

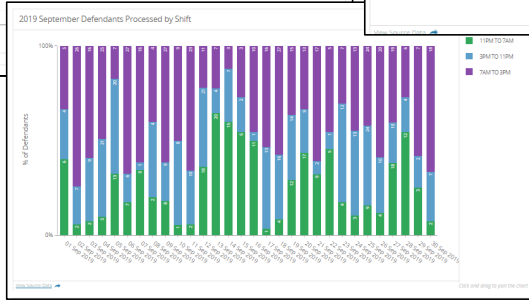

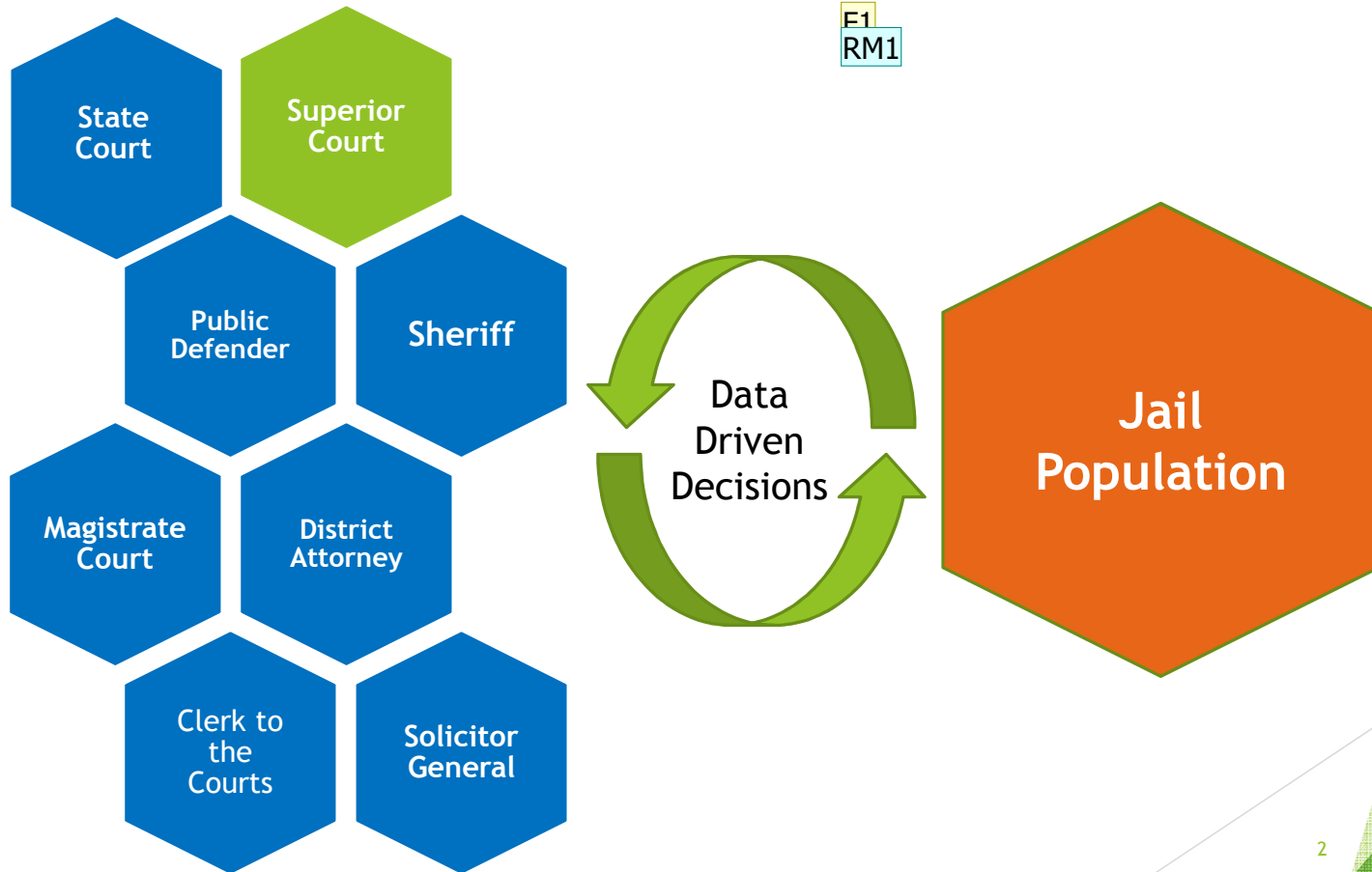

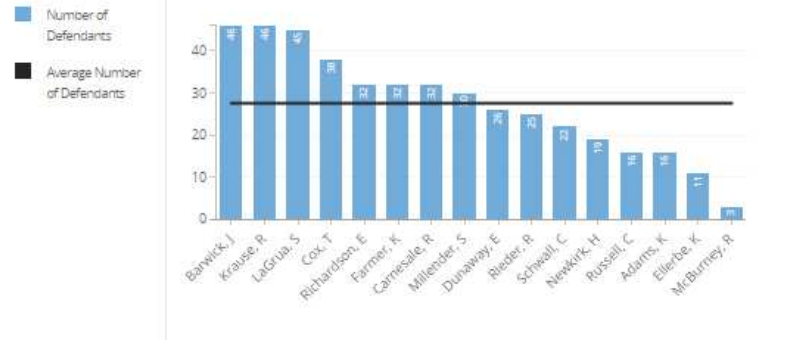

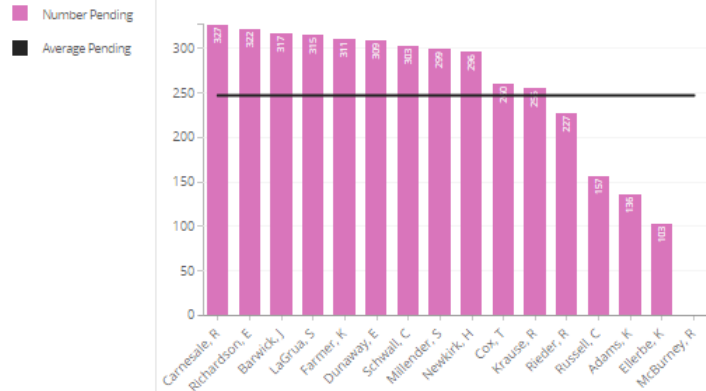

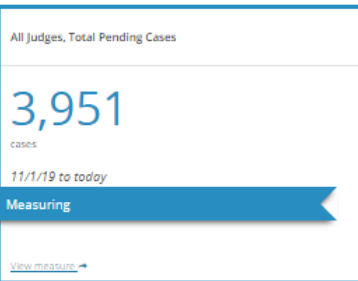

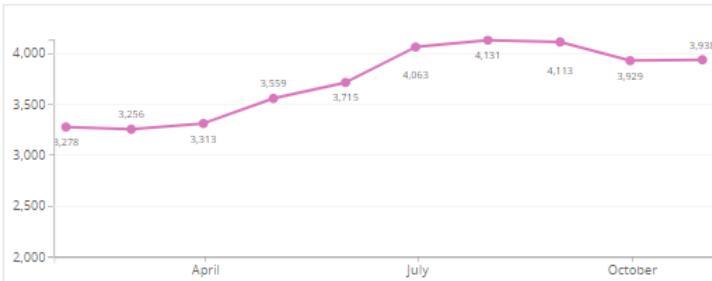

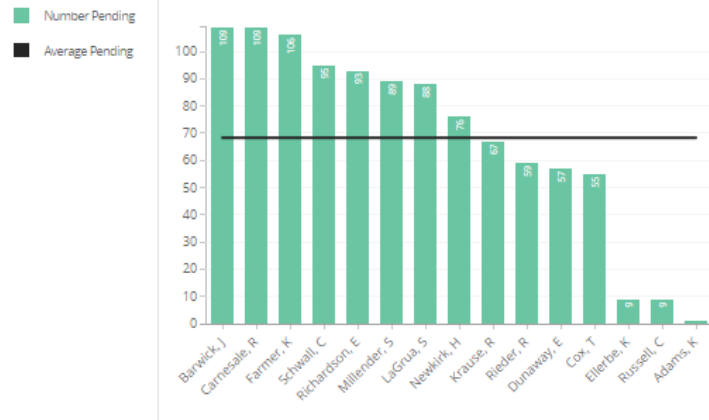

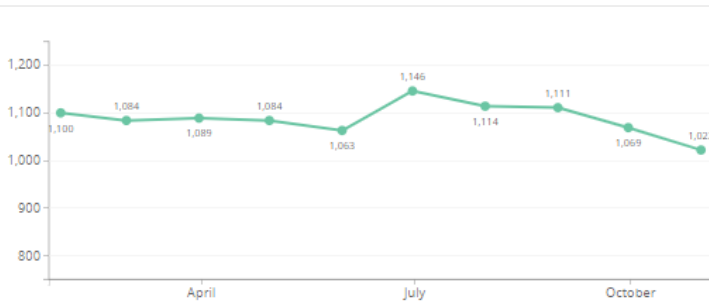
