A RESOLUTION APPROVING A LEASE AGREEMENT BETWEEN FULTON 1 2 COUNTY, GEORGIA (LESSOR) AND TIMES JOURNAL, INC., A GEORGIA CORPORATION (LESSEE), FOR THE PURPOSE OF LEASING 743 SQUARE 3 FEET OF OFFICE SPACE IN THE BASEMENT OF THE FULTON COUNTY 4 5 COURTHOUSE AT 136 PRYOR STREET, S.W., ATLANTA, GEORGIA AND RELATED DOCUMENTS; AUTHORIZING THE CHAIRMAN TO EXECUTE 6 THE LEASE AGREEMENT; AUTHORIZING THE COUNTY ATTORNEY TO 7 8 APPROVE THE LEASE AGREEMENT AND RELATED DOCUMENTS AS TO 9 FORM AND TO MAKE MODIFICATIONS THERETO PRIOR TO EXECUTION TO PROTECT THE COUNTY'S INTEREST; AND FOR OTHER PURPOSES 10 11 12 WHEREAS, Fulton County, Georgia (the "County"), is a political 13 subdivision of the State Georgia and is committed to the practice of maximizing 14 the utility of its real property assets; and 15 WHEREAS, it is a County initiative that all people trust the government to 16 be efficient, effective and fiscally sound, to manage its finances wisely, and to develop and follow policies that promote both efficient and effective practices in 17 18 all areas to include the use of its underutilized resources; and 19 WHEREAS, the County previously leased office space in the basement of 20 the Fulton County Courthouse at 136 Pryor Street, SW, to ALM Media, LLC 21 ("ALM Media"), that was originally approved as Agenda Item #17-0234 at the 22 Board of Commissioners' meeting held March 15, 2017, amended April 19, 2017 as Agenda Item #17- 0357 and December 16, 2020 as Agenda Item #20-0928 23 24 (the "Lease"): and 25 WHEREAS, the Times Journal, Inc. publication, the South Fulton 26 Neighbor, has replaced the ALM Media LLC publication, the Fulton County Daily 27 Report, as the legal organ of Fulton County and submitted a formal request to the 28 Department of Real Estate and Asset Management and the Clerk of Superior

Court of its desire to lease the 743 square feet of office space in the basement at

- 1 136 Pryor Street in the Fulton County Courthouse previously leased by ALM
- 2 Media LLC; and
- 3 **WHEREAS**, it is mutual desire of Fulton County and Times Journal, Inc.
- 4 to enter into a new lease agreement for the purpose providing office space
- 5 necessary for legal publication services to Fulton County residents that are
- 6 complementary to the services provided by the Fulton County Clerk of Superior
- 7 Court; and
- 8 **WHEREAS,** Article 9, § 2, ¶ 1(a) of the Georgia Constitution provides
- 9 that "[t]he is governing authority of each county shall have legislation power to
- adopt clearly reasonable ordinances, resolutions, or regulations relating to its
- property, affairs, and local government for which no provision has been made by
- general law and which is not inconsistent with this Constitution or any local law
- applicable thereto" and Fulton County Code § 1-117 confers upon the Board of
- 14 Commissioners the exclusive jurisdiction and control over directing and
- 15 controlling all the property of the county, as they may deem expedient, according
- 16 to law.
- 17 NOW THEREFORE, IT IS HEREBY RESOLVED, that the Board of
- 18 Commissioners of Fulton County hereby approves the "Lease Agreement"
- 19 between Fulton County, Georgia and Times Journal Inc., attached hereto in
- 20 substantial form as Exhibit "A".
- 21 **BE IT FURTHER RESOLVED**, that the Chairman of Fulton County Board
- 22 of Commissioners be authorized and directed to execute and deliver the Lease

authorized to approve the Lease Agreement as to form and to make nece	ssary

Chairman.
