**W I T N E S S E T H**

WHEREAS, Fulton County (“County”) entered into a Contract with Technical Resource Management, LLC dba Cordant Health Solutions hereinafter referred to as (“Cordant”) or (“Contractor”) to provide drug testing services, beginning November 1, 2025 and ending December 31, 2025, on behalf of the Superior Court of Fulton County (the “Original Contract”); and

WHEREAS, the County and the Contractor intended the contracted services for the initial term of the Original Contract to be July 1, 2025 through June 30, 2026 to align with the grant term that funds the Original Contract; and

WHEREAS, the Contractor has performed satisfactorily over the period of the Contract and to present; and

WHEREAS, the County and the Contractor wish to extend the written Original Contract to align the term of the Original Contract with their intentions to which they mutually assented at the time the Original Contract was executed; and

WHEREAS, the County and Contractor wish to establish a corrected written Original Contract with a term to reflect their original intent, to which they mutually assented, specifically a term of July 1, 2025, through June 30, 2026, with renewal(s) contingent on continued funding and options to renew based on grant extension(s); and

WHEREAS, no additional general fund monies are required to cover the costs of the corrected term; and

WHEREAS, this Agreement was approved by the Fulton County Board of

Commissioners on June 3, 2026, BOC Item Number 26-

**NOW, THEREFORE**, the County and the Contractor agree as follows:

The Original Contract is hereby incorporated fully herein. This Agreement is effective as of the 3rd day of June, 2026 between the County and Technical Resource Management, LLC dba Cordant Health Solutions, who agree that all Services specified will be performed in accordance with this Agreement and the Original Contract Documents.

1. **CONTRACT TERM:** The term, as reflected in Article 8 of the Original Contract, is hereby amended and shall be July 1, 2025 – June 30, 2026, with two (2) optional one-year (“Renewal Terms”), starting July 1, 2026 and July 1, 2027.
  
2. **LIABILITY OF COUNTY:** This Agreement shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
  
3. **EFFECT OF AGREEMENT TO INCORPORATE AND AMEND ORIGINAL CONTRACT:** All other provisions of the Original Contract, except those amended herein are incorporated by reference. Except as modified by this Agreement, the Contract, and all Original Contract Documents, are hereby in full force and effect.
