WITNESSETH

WHEREAS, Fulton County ("County") entered into a Contract with Hogan Construction Group, LLC/The Collaborative Firm, LLC to perform design build services for Developmental Disability Programming & Services for the construction and renovation of County facility located at 475 Fairburn Road, SW, Atlanta, Georgia 30331, dated September 18, 2024, on behalf of the Department of Real Estate and Asset Management; and

WHEREAS, it is necessary to expand the scope of work to be provided by the Contractor to increase the spending authority to include furniture, fixture and equipment and information technology equipment and services required for the Project; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this Change Order No. 1 was approved by the Fulton County Board of Commissioners on December 4, 2024, BOC Item #24-0834.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Change Order No. 1 to Form of Contract is effective as of the 4th day of December, 2024, between the County and Hogan Construction Group, LLC/The Collaborative Firm, LLC JV, who agree that all Services specified will be performed by in accordance with this Change Order No. 1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** To increase the spending authority for additional furniture, fixture and equipment required for the Project.

- 2. **COMPENSATION:** The services described under Scope of Work herein shall be performed by Contractor for a total amount not to exceed \$1,600,000.00 (One Million Six Hundred Thousand Dollars and No Cents).
- 3. **LIABILITY OF COUNTY:** This Change Order No. 1 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the County Manager, attested to by the Clerk to the Commission and delivered to Contractor.
- 4. **EFFECT OF CHANGE ORDER NO. 1 TO FORM OF CONTRACT:** Except as modified by this Change Order No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
