

1 A RESOLUTION APPROVING THE EXECUTION OF AN EASEMENT AGREEMENT
2 BETWEEN FULTON COUNTY, GEORGIA AND ATLANTA GAS LIGHT COMPANY FOR
3 THE PURPOSE OF RELOCATING AND UPGRADING SERVICE LINES ONSITE AT THE
4 FULTON COUNTY EXECUTIVE AIRPORT – CHARLIE BROWN FIELD; TO AUTHORIZE
5 THE CHAIRMAN TO EXECUTE AN EASEMENT AGREEMENT AND RELATED
6 DOCUMENTS; TO AUTHORIZE THE COUNTY ATTORNEY TO APPROVE AS TO FORM
7 THE EASEMENT AGREEMENT AND RELATED DOCUMENTS; AND FOR OTHER
8 PURPOSES.

10 WHEREAS, Fulton County, Georgia, is a political subdivision of the State of Georgia,
11 existing as such under and by the Constitution, statutes, and laws of the State; and

12 WHEREAS, the Atlanta Gas Light Company has an initiative to replace their existing
13 underground steel service lines with roskote coated lines to provide additional protection
14 against corrosion which will increase the economic life span and utility; and

15 WHEREAS, the Atlanta Gas Light Company has determined that an easement
16 agreement from Fulton County is required to complete enhancements to its infrastructure
17 and to relocate onsite natural gas service lines at the Fulton County Executive Airport –
18 Charlie Brown Field situated in Land Lots 22 and 53 of the 14th FF District of Fulton County,
19 Georgia; and

20 WHEREAS, the Fulton County Department of Real Estate and Asset Management
21 and the Department of Public Works have determined that it is in the best interest of Fulton
22 County that the Atlanta Gas Light Company be granted an easement to relocate and install
23 roskote coated service lines at the Fulton County Executive Airport – Charlie Brown Field for
24 the purpose of improving and maintaining optimum service levels for its customers; and

25 WHEREAS, pursuant to O.C.G.A. § 36-9-3, Fulton County is authorized to grant
26 easements without a competitive process; and

27 WHEREAS, pursuant to Fulton County Code Sec. 1-117, the Board of Commissioners
28 is vested with exclusive jurisdiction and control over all property of the County.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Fulton County, Georgia, hereby approves the easement agreement with the Atlanta Gas Light Company in substantially the form attached hereto as Exhibit "A".

BE IT FURTHER RESOLVED, that the Chairman of Fulton County Board of Commissioners is authorized and directed to execute and deliver the Easement Agreement and any related documents to Atlanta Gas Light Company.

BE IT FURTHER RESOLVED, that prior to execution of the Easement Agreement and any related documents, the County Attorney shall approve the documents as to form and make any necessary changes thereto to protect the County's interests.

BE IT FINALLY RESOLVED , that this Resolution shall become effective upon its adoption and that all resolutions and parts of resolutions in conflict with this Resolution are hereby repealed to the extent of the conflict.
