

1 **RESOLUTION PURSUANT TO O.C.G.A. § 15-18-19(e)(6) TO APPROVE**
2 **SALARY SUPPLEMENTS FOR STATE PAID ASSISTANT DISTRICT**
3 **ATTORNEYS**

5 **WHEREAS**, O.C.G.A. §§ 15-18-14(a)(1)-(2) limits the number of
6 Assistant District Attorneys whose salaries are paid by the State; and

7 **WHEREAS**, pursuant to O.C.G.A. § 15-18-19(e)(6), the Board of
8 Commissioners of Fulton County, the County comprising the whole of the
9 Atlanta Judicial Circuit, has been authorized to supplement those state
10 salaries; and

11 **WHEREAS**, effective January 1, 2016, pursuant to O.C.G.A. § 15-18-
12 10, any supplement by Fulton County to either the District Attorney or those
13 Assistant District Attorneys paid by the State shall not exceed \$50,000; and

14 **WHEREAS**, the District Attorney of the Atlanta Judicial Circuit and the
15 Board of Commissioners recognizes that State-funded Assistant District
16 Attorney positions are necessary and contribute to the success of the District
17 Attorney's Office; and

18 **WHEREAS**, the salaries paid by the State to Assistant District
19 Attorneys are not as competitive as the salaries offered by Fulton County for
20 County-funded Assistant District Attorney; and

21 **WHEREAS**, the District Attorney of the Atlanta Judicial Circuit and the
22 Board of Commissioners agree that offering a supplement funded by Fulton
23 County for those State-funded Assistant District Attorney positions would
24 help attract and retain prosecutors in the Office of the District Attorney.

25 **NOW, THEREFORE, BE IT RESOLVED THAT** Fulton County may, at
26 the request of the District Attorney of the Atlanta Judicial Circuit, supplement
27 the salaries of individuals in State-paid Assistant District Attorney positions

1 for an amount not to exceed \$50,000 per annum as authorized by O.C.G.A.
2 §§ 15-18-19(e)(6) and 15-18-10.1(d).

3 **BE IT FURTHER RESOLVED** that any salary supplements that are
4 \$50,000 or more shall not be increased further.

5 **BE IT FURTHER RESOLVED** that any salary supplement authorized
6 by this Resolution shall be contingent on the availability of funds within the
7 budget approved for the District Attorney of the Atlanta Judicial Circuit.

8 **BE IF FURTHER RESOLVED** that this Resolution shall be retroactive
9 to January 1, 2021.

10 **BE IT FINALLY RESOLVED** that all resolutions and parts of
11 resolutions in conflict with this Resolution are hereby repealed to the extent
12 of the conflict.
