

1 RESOLUTION APPROVING A POLE ATTACHMENT AGREEMENT,  
2 ADDENDUM TO POLE ATTACHMENT AGREEMENT AND BANNER TO  
3 POLE ATTACHMENT AGREEMENT BETWEEN FULTON COUNTY, GEORGIA  
4 AND GEORGIA POWER COMPANY FOR THE PURPOSE OF INSTALLING  
5 POLICE VIDEO SURVEILLANCE EQUIPMENT AND OTHER FULTON  
6 COUNTY BANNERS ON UTILITY SERVICE POLES; AUTHORIZING THE  
7 CHAIRMAN TO EXECUTE EACH AGREEMENT AND RELATED  
8 DOCUMENTS; AUTHORIZING THE COUNTY ATTORNEY TO APPROVE  
9 EACH AGREEMENT AND RELATED DOCUMENTS AS TO FORM AND TO  
10 MAKE NECESSARY MODIFICATIONS THEREOF PRIOR TO EXECUTION;  
11 AND FOR OTHER PURPOSES

13 WHEREAS, Fulton County Georgia, is a political subdivision of state  
14 Georgia and committed to the practice of optimizing available resources for the  
15 purpose of providing the highest level of government services and improving the  
16 quality of life for all residents and visitors of Fulton County; and

17 WHEREAS, it is a Fulton County initiative that All People Trust  
18 Government is Efficient, Effective and Fiscally Sound and implements crime  
19 prevention strategies that are efficient and effective; and

20 WHEREAS, the Fulton County Department of Police Services has  
21 identified areas in unincorporated Fulton County to employ crime reduction and  
22 prevention initiatives that will improve the safety of Fulton County residents and  
23 visitors; and

24 WHEREAS, the Fulton County Department of Police Services finds that  
25 the installation of video surveillance equipment will assist it in reducing crimes to  
26 persons and properties; and

27 WHEREAS, prior to attaching police video surveillance equipment and  
28 banners to utility service poles maintained by the Georgia Power Company  
29 ("GPC") formal agreements to include the terms under which such installations

1 can be made must be approved by the Fulton County Board of Commissioners;  
2 and

3 **WHEREAS**, prior to granting the Fulton County Police Department  
4 permission to attach video surveillance equipment or the County generally to  
5 attached banners to GPC's utility service poles, GPC requires that all  
6 organizations complete a Pole Attachment Agreement, Addendum To Pole  
7 Attachment Agreement, and Banner To Pole Attachment Agreement, each  
8 attached hereto as Exhibit "A"; and

9 **WHEREAS**, pursuant to O.C.G.A. § 36-10-1, all contracts entered into by  
10 the County shall be in writing and entered on its minutes.

11 **NOW THEREFORE, IT IS HEREBY RESOLVED**, that the Board of  
12 Commissioners of Fulton County hereby authorizes the Chairman to execute a  
13 Pole Attachment Agreement, Addendum to Pole Attachment Agreement, and a  
14 Banner to Pole Attachment Agreement with GPC, substantially in the form of  
15 each attached hereto as Exhibit "A."

16 **BE IT FURTHER RESOLVED**, that the Fulton County Board of  
17 Commissioners hereby authorizes the County Attorney to approve each  
18 agreement and related document as to form and to make modifications thereof to  
19 protect Fulton County's interests prior to their execution.

20 **BE IT FINALLY RESOLVED**, that this Resolution shall become effective  
21 upon its adoption, and that all resolutions and parts of resolutions in conflict with  
22 this Resolution are hereby repealed to the extent of the conflict.
