RESOLUTION URGING THAT THE FULTON COUNTY DEVELOPMENT 1 2 AUTHORITY EXPLORE UNDERTAKING A WORKFORCE HOUSING AND 3 WORKFORCE DEVELOPMENT INITIATIVE AND PROVIDE **RECOMMENDATIONS FOR THE USE OF COUNTY-OWNED PROPERTY IN** 4 5 SUPPORT OF ANY SUCH INITIATIVES 6 7 WHEREAS, pursuant to the authority granted by O.C.G.A. § 36-62-1 et seq., the 8 Fulton County Board of Commissioners established the Fulton County Development 9 Authority ("FCDA"), for the purpose of developing and promoting welfare, trade, commerce, industry and employment opportunities in Fulton County 10 and thereby 11 promoting the general welfare of its citizens; and **WHEREAS**, the FCDA Board has the authority to set policy for itself in carrying 12 13 out the FCDA's purpose of providing for the general welfare of County citizens; and WHEREAS, pursuant to Fulton County Code ("FCC") Section 118-48, the 14 members of the FCDA also serve as an advisory committee to the Board of 15 16 Commissioners for the purpose of conducting studies and making recommendations for 17 the future development, use and sale of County-owned property; and 18 WHEREAS, the Board of Commissioners has determined that it is desirable to 19 provide increased quality affordable housing and workforce development options for its citizens and employees; and 20 21 **WHEREAS**, the FCDA can support or implement quality affordable housing and workforce development initiatives in the County if said initiatives promote the public 22 23 good and general welfare of the County and comport with the powers granted to the 24 FCDA by state and local law; and WHEREAS, the FCDA can also support affordable housing and workforce 25 26 development initiatives by utilizing its authority to act as an advisory committee to

conduct studies and make recommendations for County-owned property, which could
 be used in support of such initiatives; and

WHEREAS, given the organization's purpose of promoting trade, commerce,
industry and employment, the FCDA is uniquely positioned to encourage development
in Fulton County that can foster increased affordable housing and workforce
development opportunities.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Fulton County urges the FCDA to explore undertaking a Workforce Housing Policy for the provision of quality affordable housing for Fulton County employees and a Workforce Development initiative for employees and citizens of the County, within the confines of the powers granted to it by state and local law which promotes the development of trade, commerce, industry and employment opportunities within the County as a whole.

BE IT FURTHER RESOLVED, that the FCDA is also urged to undertake its
 advisory committee function and provide recommendations to the Board of
 Commissioners in support of an affordable housing and/or workforce development
 inititive with respect to County-owned property.

BE IT FURTHER RESOLVED, that the Clerk to the Commission is hereby
 directed to spread this Resolution upon the official minutes and records of the Board of
 Commissioners of Fulton County.
