

1 **A RESOLUTION AUTHORIZING FULTON COUNTY’S SUBMISSION OF THE FY**
2 **2021 ANNUAL ACTION PLAN TO THE U.S. DEPARTMENT OF HOUSING AND**
3 **URBAN DEVELOPMENT (HUD); AUTHORIZING THE EXECUTION OF CERTAIN**
4 **CERTIFICATIONS BY THE COUNTY MANAGER OR THE DIRECTOR OF THE**
5 **DEPARTMENT OF COMMUNITY DEVELOPMENT OR THEIR DESIGNEES; AND**
6 **FOR OTHER PURPOSES.**

8 **WHEREAS**, Fulton County, Georgia, is eligible to receive federal funds available
9 through the Department of Housing and Urban Development as a designated Urban
10 County; and

11 **WHEREAS**, in order to receive funding, Fulton County prepared a Five-Year
12 Consolidated Plan for FY 2020-2024, in compliance with 24 CFR Parts 91, 92, 570,
13 574, 576 and 968; and

14 **WHEREAS**, the Five Year Consolidated Plan for FY 2020-2024 establishes goals
15 for the use of the federal funds for the Community Development Block Grant Program,
16 the HOME Investment Partnerships Program and the Emergency Solutions Grant
17 Program, and identifies how Fulton County will meet the requirements of these
18 programs in the administration of federal funds; and

19 **WHEREAS**, the FY 2021 Annual Plan allocates funding to specific activities to be
20 undertaken during the year to meet the goals established in the Five Year Consolidated
21 Plan; and

22 **WHEREAS**, the U.S. Department of Housing and Urban Development requires
23 certain certifications to be submitted as part of the submission of the FY 2021 Annual
24 Plan; and

25 **WHEREAS**, the Board of Commissioners finds that providing these submissions
26 would best serve the interests of the citizens of Fulton County.

27 **NOW THEREFORE, BE IT RESOLVED**, by the Board of Commissioners of the
28 County of Fulton, Georgia being the governing body thereof, as follows:

- 29 1. The Chairman of the Board of Commissioners of Fulton County, Georgia is
30 hereby authorized to submit the Action Plan for FY 2021, including all
31 understandings and assurances contained therein, to be utilized to obtain the
32 fullest extent of funding allowed and determined by the Department of
33 Housing and Urban Development, under the Housing and Community
34 Development Act of 1974, as amended, the Homeless Emergency Assistance
35 and Rapid Transition to Housing Act of 2009, and the Cranston-Gonzalez
36 National Affordable Housing Act, and to act as the authorized representative
37 of Fulton County and is authorized herby to provide such additional
38 information as may be required.

40 2. The County Manager or Director of the Department of Community
41 Development, or their designees, are hereby authorized and directed to
42 execute on behalf of Fulton County such certification or certifications as may
43 be required under the rules and regulations of the U.S. Department of
44 Housing and Urban Development (HUD) and to execute the Funding
45 Agreements upon receipt from HUD.

47 **BE IT FINALLY RESOLVED**, that this Resolution shall become effective upon its
48 adoption, and that all resolutions and parts of resolutions in conflict with this Resolution
49 are hereby repealed to the extent of the conflict.
