A RESOLUTION TO CORRECT CLERICAL ERRORS BY THE CLERK TO THE COMMISSION RELATING TO THE TERMS OF SERVICE FOR THE NEWLY APPOINTED BOARD MEMBERS OF THE HOUSING AUTHORITY OF FULTON COUNTY; AND FOR OTHER PURPOSES.

WHEREAS, Article II, Sec. 101-66 of the Fulton County Code establishes agenda preparation for all Board of Commissioners meetings as the duty of the Clerk to the Commission; and

WHEREAS, Article III, Sec. 102-115 of the Fulton County Code establishes that the Clerk to the Commission shall prepare in written form the minutes of each Board of Commissioners meeting after adjournment; and

WHEREAS, the Board of Commissioners held a special called meeting on July 29, 2024 to, among other matters of business, approve new district nominees to serve as Housing Authority of Fulton County ("Housing Authority") board members; and

WHEREAS, the Clerk to the Commission erred in the preparation of the July 29, 2024 special called meeting post-agenda minutes by failing to identify that the district nominees to the Housing Authority board were to fill the unexpired terms of their predecessors; and

WHEREAS, the Clerk to the Commission further erred in the presentation of post-agenda minutes from the July 29, 2024 special called meeting for ratification to the Board of Commissioners on August 7, 2024 without including term lengths for the district appointments to the Housing Authority board; and

WHEREAS, the Board of Commissioners held a regular meeting on August 7, 2024 to, among other matters of business, approve a new district nominee to the Housing Authority board; and

WHEREAS, the Clerk to the Commission erred in the preparation of the August 7, 2024 regular meeting agenda by failing to identify that the district nominee to the Housing Authority board was to fill the unexpired term of his predecessor, and by incorrectly listing the term end date as July 13, 2029 instead of the correct end date of July 13, 2027; and

WHEREAS, the Clerk to the Commission further erred in the preparation of the August 7, 2024 regular meeting post agenda minutes by failing to identify that the district nominee to the Housing Authority board was to fill the unexpired term of his predecessor, and by incorrectly listing the term end date as July 13, 2029 instead of the correct end date of July 13, 2027; and

WHEREAS, Article III, Sec. 102-115 of the Fulton County Code allows the Clerk to the Commission to correct previously approved minutes "upon orders of and approval by the county commission in a subsequent regular or called meeting."

NOW, THEREFORE, BE IT RESOLVED, that the Clerk to the Commission is ordered to correct the post agenda minutes of the July 29, 2024 special called meeting

by identifying that each district nominee was appointed to the unexpired term of their respective predecessor, and by listing the correct term end date for each appointee. 2 3 BE IT FURTHER RESOLVED, that the Clerk to the Commission is ordered to 4 correct the post agenda minutes of the August 7, 2024 regular meeting by identifying that 5 the district nominee was appointed to fill the unexpired term of his predecessor, and by 6 listing the correct term end date. 7 BE IT FURTHER RESOLVED, that the Clerk to the Commission is ordered to 8 correct the Housing Authority document published on the Fulton County website to reflect 9 the correct term end dates for the members of the Housing Authority board which are currently incorrectly listed as all ending on July 13, 2029. 10 11 BE IT FINALLY RESOLVED, that this Resolution shall become effective upon its adoption, and that all resolutions and parts of resolutions in conflict with this Resolution 12 are hereby repealed to the extent of the conflict. 13 14 **SO PASSED AND ADOPTED**, this 21st day of August, 2024. **FULTON COUNTY BOARD OF** 15 **COMMISSIONERS** 16 Sponsored by: 17 18 19 20 Robert L.
