AMENDMENT NO. 3 TO FORM OF AGREEMENT

This Amendment 3 to the Emergency Authorization Agreement is made and entered into this 31st day of March 2024, between Fulton County, Georgia, a political subdivision of the State of Georgia, hereinafter referred to as "County" and **A & A ALL COUNTY MONITORING SERVICES,** hereinafter referred to as "Contractor", authorized to transact business in the State of Georgia.

- 1. **SCOPE OF WORK TO BE PERFORMED:** To continue to provide ankle monitoring services for the Court Backlog Project ("Project ORCA") for an additional ninety (90) day period beginning March 31, 2024 through April 30, 2024.
- 2. **COMPENSATION:** The services herein shall be performed by Contractor in an amount not to exceed \$305,000.00 (Three Hundred Five Thousand Dollars and No Cents).
- 3. **LIABILITY OF COUNTY:** This Amendment No. 3 to Form of Agreement shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the County and delivered to

Contractor.

4. **EFFECT OF AMENDMENT NO. 3 TO FORM OF AGREEMENT:** Except as modified by this Amendment No. 3 to Form of Agreement and the Agreement, and all Agreement Documents, remain in full force and effect.
