

**FIRST EXTENSION OF THE FULTON COUNTY SOLICITOR-GENERAL'S  
OFFICE COVID INTERNSHIP PROGRAM GRANT AGREEMENT**

**This First Extension to the Agreement ("First Extension")** is made and entered this \_\_\_\_ day of July, 2021, by and between the Board of Regents of the University System of Georgia by and on behalf of the University of Georgia's School of Public & International Affairs ("**UGA**"), having its principal office at 202 Herty Drive, Candler 109, Athens, Georgia 30602, and the Office of the Fulton County Solicitor General ("**County**") (together, the "**Parties**").

**WHEREAS**, the Parties entered into an agreement on April 21, 2021 (the "Original Agreement") by which UGA would reimburse certain costs to the County to engage interns to complete projects related to law, government, and public policy; and

**WHEREAS**, the Original Agreement contemplated the County engaging as many as ten (10) interns (the "UGA Interns") to work as many as two hundred (200) hours per intern; and

**WHEREAS**, the Original Agreement terminated on June 30, 2021, before the UGA Interns were able to complete the hours contemplated under the Original Agreement; and

**WHEREAS**, the parties agree that the educational interests of UGA and the UGA Interns and the County's interest in providing quality services to the citizens of the County would be served by extending the Original Agreement; and

**WHEREAS**, the Parties desire, through this First Extension, to extend the Original Agreement under the same terms and conditions set forth in the Original Agreement up to and including September 1, 2021.

**NOW THEREFORE**, UGA, and the County, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, do hereby agree as follows:

**Section 1.** UGA, and Fulton County do hereby agree to this First Extension of the Original Agreement up to and including September 1, 2021. The Parties further agree that all the terms and conditions set out in the Original Agreement, as modified by this First Extension, will continue to be enforceable during the extension period.

**Section 2.** The Original Agreement, as modified by the First Extension, contains the entire agreement between the Parties, and no modification shall be binding upon the Parties unless evidenced by a subsequent written agreement signed by Fulton County acting by and through the Fulton County Board of Commissioners, and UGA, acting by and through its duly authorized officers.

**Section 3.** The provisions of the Original Agreement, as modified by the First Extension, shall be deemed independent and severable. In the event any one or more of the provisions contained herein shall, for any reason, be held invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provision of the Original Agreement, as modified by the First Extension.

**Section 4.** The Original Agreement, as modified by the First Extension, shall be governed in all respects as to the validity, construction, capacity performance, or otherwise by the laws of the State of Georgia.

**Section 5.** Nothing contained in the Original Agreement, as modified by the First Extension, shall be constructed to be a waiver of any of the Parties' sovereign immunity, any individual's qualified immunity, or any other immunity or exemption from liability provided for by law.

**Section 6.** The Original Agreement, as modified by the First Extension, shall not be construed as, or deemed to be, an agreement for the benefit of any third party or parties, and no third party or parties shall have any right of action hereunder for any cause whatsoever.

**Section 7.** Except as modified by this First Extension, all terms and conditions of the Original Agreement remain in full force and effect.

Request approval for 2021 Community Development Block Grant (CDBG) funds contractual agreements with (1) City of College Park for Barrett Park Improvements (\$102,700.00); (2) East Point Waterline Infrastructure Upgrade Phase II (\$152,700.00); (3) City of Fairburn for Margaret Street Pedestrian Improvements (\$239,338.00); (4) City of Hapeville for Tom E. Morris Splash Pad (\$102,700.00); (5) City of Palmetto for Veterans Park Improvements (\$102,700.00); and (6) Union City for Oakley Road Street Resurfacing (\$177,700.00); and Authorize the Chairman to execute the contractual agreements and related documents for the disbursement of funds consistent with the federal programs and this Board action; Authorize the County Attorney to approve these contracts as to form and to make modifications thereto prior to execution. The funds are 100% grant funded.
