WHEREAS, Fulton County, Georgia (the "County") intends to (i) acquire, design, construct, renovate, improve, add to, install and equip existing and/or new County buildings and facilities, acquire property, both real and personal, necessary or desirable for use in connection therewith and pay expenses incident thereto, all as more particularly described in Exhibit A attached hereto (collectively, the "Projects"); (ii) pay costs of the Projects from available funds of the County prior to the issuance or incurrence of bonds or other obligations or debt (the "Bonds") to finance the Projects; and (iii) reimburse itself for such original expenditures (the "Expenditures") from the proceeds of the Bonds; and WHEREAS, bond counsel has advised the County that Treas. Regs. § 1.150-2

WHEREAS, bond counsel has advised the County that Treas. Regs. § 1.150-2 requires the County to adopt a resolution in the form set forth below to preserve the County's ability to use portions of the proceeds of upcoming Bond issue(s) of the County, the South Fulton Municipal Regional Jail Authority (the "Authority") and/or any other conduit issuer to reimburse itself for the Expenditures; and

WHEREAS, after careful consideration the Board of Commissioners of Fulton County has determined it appropriate to adopt this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF FULTON COUNTY THAT:

1. The County intends to finance the Projects through the issuance by the County, the Authority and/or any other conduit issuer of one or more series of Bonds. The principal amount of the Bonds attributable to the Projects is not currently expected to exceed \$1,685,000,000.
