WHEREAS, Fulton County ("County") entered into a Contract with **Core and Main, LP** to provide Fire Hydrants and Parts, dated 10th day of October 2024 on behalf of the Department of Public Works; and

WHEREAS, the County wishes to amend the existing contract to increase the spending authority to cover the cost of procurement additional fire hydrants and parts to restore stock to operation levels; and

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this Amendment was approved by the Fulton County Board of Commissioners on _____ through Agenda Item No. _____.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Amendment No.1 to Form of Contract is effective as of _____, between the County and Core and Main, who agree that all Services specified will be performed in accordance with this Amendment No.1 to Form of Contract and the Contract Documents.

1. **SCOPE OF WORK TO BE PERFORMED:** The Second Renewal of this contract was approved by the Board of Commissioners as Agenda Item No. 25-0680 on September 17, 2025. Core & Main is requesting an average price increase over the previously approved unit prices due to rising freight surcharges and increased costs of resins and other raw materials from the manufacturer. This request for an increase covers the cost of procuring fire hydrants and parts.
2. **COMPENSATION:** The services described under Scope of Work herein shall be

performed by Contractor for a total amount not to exceed \$238,570.00 (Two Hundred Thirty-Eight Thousand Five Hundred Seventy Dollars and No Cents). approved by BOC.

3. **LIABILITY OF COUNTY:** This Amendment No.1 to Form of Contract shall not become binding on the County, and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF AMENDMENT NO.1 TO FORM OF CONTRACT:** Except as modified by this Amendment No.1 to Form of Contract, the Contract, and all Contract Documents remain in full force and effect.
