FY2025, FY2026, FY2027, FY2028, and FY2029 Agreement

FY2025 Amendment

THIS AMENDMENT TO AID AGREEMENT, between FULTON COUNTY (hereinafter referred to as "County") a political subdivision of the State of Georgia, acting by and through its duly elected Board of Commissioners ("BOC"), and **Georgia Harm Reduction Coalition, Inc.** (hereinafter referred to as "Subrecipient"). THIS Amendment shall be referenced as EHE25-29-002 – any future amendments will be numbered sequentially.

WITNESSETH:

WHEREAS, the County desires to amend said agreements entered into the 1st day of **August** 2025 through the 28th day of February 2030 pursuant to Item #25-0555 (8/6/2025).

NOW, THEREFORE, in consideration of the mutual covenants contained herein and for other good and valuable consideration, the parties hereunto agree as follows:

ARTICLE 6. **CONTRACT TERM**

The Agreement is hereby amended to revise ARTICLE 6. **CONTRACT TERM**, as follows:

Paragraph 6.0. This Agreement is effective on **August 1, 2025**, for a term expiring on **February 28, 2030**.

Paragraph 6.1. The "Commencement Term" of this Agreement shall begin on **August 1, 2025**, and shall end absolutely and without further obligation on the part of the County on the **28th day of February 2030**. The Commencement Term shall be subject to events of termination and the County's termination rights that are described elsewhere in this Agreement.

ARTICLE 10. **FUNDING EXCLUSIONS AND RESTRICTIONS**

The Agreement is hereby amended to revise ARTICLE 10. **FUNDING EXCLUSIONS AND RESTRICTIONS**, by amending Paragraph 10.1 as follows:

Paragraph 10.1. Subrecipient agrees that EHE funds will not be used to supplant or replace state and local HIV-related funding or in-kind resources expended by Subrecipient for HIV-related services during the contract period beginning **August 1, 2025** and ending February 28, 2030.

CONSUMER DISCLOSURE

From time to time, Carahsoft OBO Fulton County, Georgia (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
