AMENDMENT TO CONTRACT 21ITB129242B-YJ

This Amendment to Contract, dated <u>12/14/2022</u> (this "<u>Amendment</u>"), is between EBSCO Information Services, LLC ("<u>EBSCO</u>") and <u>Fulton County Library System</u> ("<u>Customer</u>").

WHEREAS, the parties have entered into a Contract, effective as of $\frac{7/14/2021}{}$ (the "Contract"); and

WHEREAS parties hereto desire to amend the Contract on the terms and subject to the conditions set forth herein.

NOW, THEREFORE, in consideration of the premises set forth above and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. <u>Amendment</u>. The Contract is amended to increase the processing fee applied to publisher refunds for cancellations from \$15.00 per title to \$30.00 per title.
- 2. <u>Miscellaneous</u>. This Amendment shall inure to the benefit of and be binding upon each of the parties and each of their respective successors and assigns. This Amendment may be executed in counterparts, each of which is deemed an original, but all of which constitutes one and the same agreement. This Amendment constitutes the sole and entire agreement of the parties with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations and warranties, both written and oral, with respect to such subject matter. Except as expressly provided in this Amendment, all of the terms and provisions of the Agreement are and will remain in full force and effect and are hereby ratified and confirmed by the parties.
