WHEREAS, Fulton County ("County") entered into a Contract with Transdev Services, Incorporated to provide/perform transportation services for seniors, dated 1th of January, 2017, on behalf of the Department of Senior Services; and

Whereas, the County wishes to extend the contract for an additional three (3) months as the Department of Senior Services go through another bid process to procure a vendor.

WHEREAS, the Contractor has performed satisfactorily over the period of the contract; and

WHEREAS, this Extension was approved by the Fulton County Board of Commissioners on October 6, 2021, BOC#21-0775.

NOW, THEREFORE, the County and the Contractor agree as follows:

This Extension No. 1 to Form of Contract is effective as of the 1st day of January, 2022, between the County and Transdev, Incorporated who agree that all Services specified will be performed by in accordance with this Extension No. 1 to Form of Contract and the Contract Documents for an additional three (3) month period, with the contract ending as of 31st day of March, 2022.

1. **COMPENSATION:** The services herein shall be performed by Contractor for a total amount not to exceed \$1,264,222.35.

3. **LIABILITY OF COUNTY:** This Extension No. 1 to Form of Contract shall not become binding on the County and the County shall incur no liability upon same until such agreement has been executed by the Chair to the Commission, attested to by the Clerk to the Commission and delivered to Contractor.
4. **EFFECT OF EXTENSION NO. 1 TO FORM OF CONTRACT:** Except as modified by this Extension No. 1 to Form of Contract, the Contract, and all Contract Documents, remain in full force and effect.
