#### CONSUMER DISCLOSURE

From time to time, Carahsoft OBO Fulton County, Georgia (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ## **Grow the Good Fulton County**

Would put over \$610,000 worth of fresh fruit and vegetables directly into the hands of SNAP families in Fulton County.

- SNAP is a sustainable entitlement program
- WWG has been doubling SNAP benefits on fruits and vegetables in Fulton County since 2009

Would provide \$915,000 in economic activity directly to Fulton County farmers and small grocery stores.

Would provide WWG the funds necessary to open more sites across the county to meet the ever increasing food insecurity challenges in Fulton County.

Currently operating in 23 locations across the county and will open a minimum of 10 new locations with priority given to locations where we are not currently operating.

- Looking to expand to brick and mortar locations because of the expanded operating hours.
- Will add new Farm Partners Miller City and Urban Farm in South Fulton
- In order to ensure greater community participation, WWG will host 3 focus groups with current Fulton County SNAP recipients to determine new locations (will provide gift certificates to participants)

WWG uses Salesforce to measure fruit and vegetables incentive utilization across all locations

- Tracks EBT swipes
- Tracks amount of incentives provided
- Tracks incentive use at each location
- Tracks number of new participants
- Tracks number of returning participants

WWG performs an annual customer satisfaction survey at locations and uses customer feedback to inform decision making around the program. These satisfaction surveys inform program success and obstacles and provide direct feedback to further shape and develop the program.

WWG will also provide SNAP enrollment screenings at Fulton County locations to assist families with enrollments and renewals. These SNAP enrollment screenings will be held at the various partner locations and at the WWG Office on Cleveland Ave. in East Point.

WWG will host additional Plant2Plate events in Fulton County during the proposed period. Plant2Plate is a project that provides SNAP beneficiaries with fruit and vegetable plants and free gardening kits to grow fresh food safely at home. Plant starts are eligible for purchase with EBT and this project has proved to be a wonderful first exposure shopping at local farms.
