AN ORDINANCE TO AMEND CHAPTER 38 (HUMAN RELATIONS), ARTICLE II (DISCRIMINATION IN PLACES OF PUBLIC ACCOMMODATION), SECTIONS 38-32(B) AND 38-33(A) OF THE FULTON COUNTY CODE OF ORDINANCES TO ADOPT A POLICY AGAINST DISCRIMINATION ON THE BASES OF SEXUAL ORIENTATION, GENDER IDENTITY, AND GENDER EXPRESSION; AND FOR OTHER PURPOSES.

WHEREAS, the Fulton County Board of Commissioners ("Board") is dedicated to a policy of non-discrimination within Fulton County and is committed to creating an environment that fosters and enhances diversity in public accommodations; and

WHEREAS, Fulton County desires to safeguard the rights and opportunities of all persons to be free from discrimination in public accommodations; and

WHEREAS, on July 27, 1988, the Board enacted Chapter 38, Article II, Sections 38-32 and 38-33, which prohibit discrimination in places of public accommodation based on sex, race, color, religion, creed or national origin of such person; and

WHEREAS, the Board finds that it is in the best interest of the County and its residents to amend its non-discrimination policy in Fulton County Code of Ordinances Section 38-31 et seq. to encompass additional protected classes including sexual orientation, gender identity, and gender expression; and

WHEREAS, the Board has authority pursuant to the Constitution of the State of Georgia, Article 9, Sec. 2 § 1(a), to adopt reasonable ordinances, resolutions, or regulations relating to its affairs for which no provision has been made by general law and which is not inconsistent with the Constitution or any local law applicable thereto.

NOW, THEREFORE, BE IT ORDAINED, that the Board hereby amends Section 38-32(b) of the Fulton County Code of Laws as follows:

(b) It is hereby declared to be the policy of unincorporated Fulton County, Georgia, in the exercise of its police power for the public safety, public health, and general welfare to provide within constitutional limitations, that the accommodations, advantages, facilities, and privileges in any place of public accommodation, resort, or amusement shall not be denied to any person because of the sex, race, color, religion, creed, or national origin, sexual orientation, gender identity, or gender expression of such person. **BE IT FURTHER ORDAINED**, that the Board hereby amends Section 38-33(a) of the Fulton County Code of Laws as follows:

- (a) Except as exempted by subsections (b), (c) and (d) of this section, it shall be unlawful for any person being the owner, lessee, proprietor, manager, superintendent, agent, or employee of any place of public accommodation, resort, or amusement:
 - (1) Directly or indirectly, to refuse, withhold from or deny to any person of the accommodations, advantages, facilities or privileges thereof because of the sex, race, color, religion, creed, or national origin, sexual orientation, gender identity, or gender expression of the person.
 - (2) Directly or indirectly, to publish, circulate, issue, display, post, or mail any written or printed communication, notice, or advertisement, to the effect that any of the accommodations, advantages, facilities, and privileges of any such place shall be refused, withheld from or denied to any person on account of sex, race, color, religion, creed, er national origin, sexual orientation, gender identity, or gender expression, or that the patronage or custom of any person belonging to or purporting to be of any particular sex, race, color, religion, creed, er national origin, sexual orientation, gender identity, or gender expression is unwelcome, objectionable, or not acceptable, desired, or solicited.

BE IT FINALLY ORDAINED, that this Ordinance shall take effect upon its adoption, and all ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.
