INCIDENT RESPONSE REVIEW


- Covid Deaths Fulton County: There have been more Covid deaths attributed to OMICRON (430) than Delta (232) last summer, (92% of those deaths were from the unvaccinated population).
- Cases, % positives and now Hospitalizations have steadily increased since last Mayors meeting.
- * Reported case counts are thought to be at least 1/3rd of the real case count. due to milder symptoms for the vaccinated population and the difficulty in tracking at home testing.
- BA.2.12.1 variant now accounts for 62% of all new cases while 30% are from a the sub-variant BA.2 & OMICRON is now 8%
- ✤ BA.2.12.1 is more transmissible than its predecessors
- Vaccine: 1st Booster now available for 5 and over. 2nd booster for those over 55 and four months since 1st booster.

7-day average for cases is **289**, 7-day average for % positive is **15.4%**, 7-day average, hospitalizations is **117**, 7 day average, for deaths is **0.1**








Developed a new testing model - PCR testing kiosks

- Public / Employee / Family Use
- Kiosks dispense a self swab test kit & a sample collection box is co-located
- Results will be delivered in 48 to 72 hrs
- No copayment when using medical insurance
- Private pay options
- Fulton County's first three units are located in the government center, the courthouse and Rice Street

BACKGROUND

Since the beginning of COVID-19, the Fulton County Court System has amassed a significant and unprecedented level of cases. To address this challenge, we will utilize a combination of capacity expansion and productivity enhancement initiatives.

Case Accumulation Defined


All cases (hearings, filings, applications) that were initiated before and during the pandemic (including those currently awaiting formal charging or filing) that have been impacted due to current limitations at various stages of the case administration process.

CASE REDUCTION STRATEGY

Snapshot of Daily Virtual Hearings





How to read the graph below: If the orange line is **above** the gray line that means that the court is **behind** and will finish processing cases after the deadline; and if the orange line is **below** the gray line that means the court is processing cases in a **timely fashion** and should finish the backlog before the deadline.

Executive Summary

- South Fulton Capacity Study projections are proving accurate
 - Demand for projects and system expansions are needed
- Continued revenue/expenses imbalance will create a decrease in capital balance and unsustainable
- In order to prevent a depletion of funds and maintain a steady balance to allow Fulton County to continue providing its services as well as fund the projects raised in the capacity studies, a rate increase of 5% is proposed for the next 3 years



REDISTRICTING

SUCCESSES

- 373 precincts redistricted
- Contracted with Blue Raster to enhance layer of check and balance

CHALLENGES

Short window of redistricting process

FUTURE IMPROVEMENTS

- Develop routine schedule for street maintenance updates
- Continue contracted services through General Election cycle
- Planned mailers to voters with updated precinct districts for November election cycle



ADVANCE VOTING

SUCCESSES

- 30 locations opened timely every day
- 90,000+ voters processed during advance voting
- 5,500+ absentee by mail ballots processed
- 270+ workers successfully recruited and trained

CHALLENGES

- No show/drop out of advance voting workers
- COVID-19 breakouts

FUTURE IMPROVEMENTS

- Streamline training
- Increase quantity of reserve workers
- Survey Advance Voting workers for input on improvements



General Primary Election May 24, 2022

SUCCESSES

- 248 poll sites opened on time
- 89,000+ Election Day voters
- 2000+ Election Day poll workers recruited

CHALLENGES

- 2 polling locations opened late
- Delay in vote tally on Election night
- Recruitment and no show election day workers due to the holiday



FUTURE IMPROVEMENTS

- Increased Regional Coordinator staff with smaller poll worker recruitment regions
- Survey Election Day poll workers for input on improvements
- Reorganize and increase staff for memory card transport to tabulation center

Elections Warehouse Update

TEMPORARY SPACE

- Warehouse space remains unchanged until the conclusion of the runoff election.
- Temporary warehouse space is being secured in a centralized location;
- currently in negotiation; contract expected to be finalized in early June.

PERMANENT SPACE

- Permanent warehouse space is under construction.
- Projected occupancy date is December 2022.
