



(20th consecutive week in **High** level)















Fig. 1. Probable and Confirmed Cases of Monkeypox in Fulton County, GA







Workforce Messaging

- **Leadership:**

- Department Directors are empowered to implement precautions to address or prevent COVID-19 outbreaks among their employees.

- **Prevention Strategies:**

- Mask wearing is encouraged among employees, and may be required in some circumstances.
- PPE is distributed to departments monthly.
- Vaccines, including boosters, are strongly encouraged.

- **Monitoring:**

- Home test kits were distributed to all departments. In addition, employees may order more test kits from the federal government.
- Employees are still required to report COVID-19 positive status for monitoring in HR system, whether from at-home (antigen) test or PCR test.

PROJECT OVERVIEW

Since the beginning of COVID-19, the Fulton County Court System has amassed a significant and unprecedented level of cases. Project ORCA will address this challenge by utilizing a combination of capacity expansion and productivity enhancement initiatives to expedite the case adjudication process.

The COVID-19 Case Resolution Project began on **December 6, 2021** with **149,200** open and active cases.


As of **September 18, 2022**, there are **65,809** pending open and active cases.







PROCESS ENHANCEMENTS



Deliberate data review and continuous improvement in key areas help to maintain case resolution velocity.

✓ Courtroom Management System

The newly implemented CMS software will assist in increasing hearing space availability; since its implementation, 138 spaces have been made available and more than 200 space reservations have been made.


✓ Additional ZOOM Rooms

The additional rooms have significantly increased the jail hearing capacity by allowing Superior Court judges to hear inmate cases once a week instead of every 10-12 days and by providing State Court judges with their own dedicated ZOOM room.


✓ Evening Hearings

Evening Bond hearings increased hearing capacity and reduced the pending bond hearing wait from 100+ days back to the pre-pandemic standard of 14 days.


DETAINEES BY JUDGE AS OF 9/6/2022
