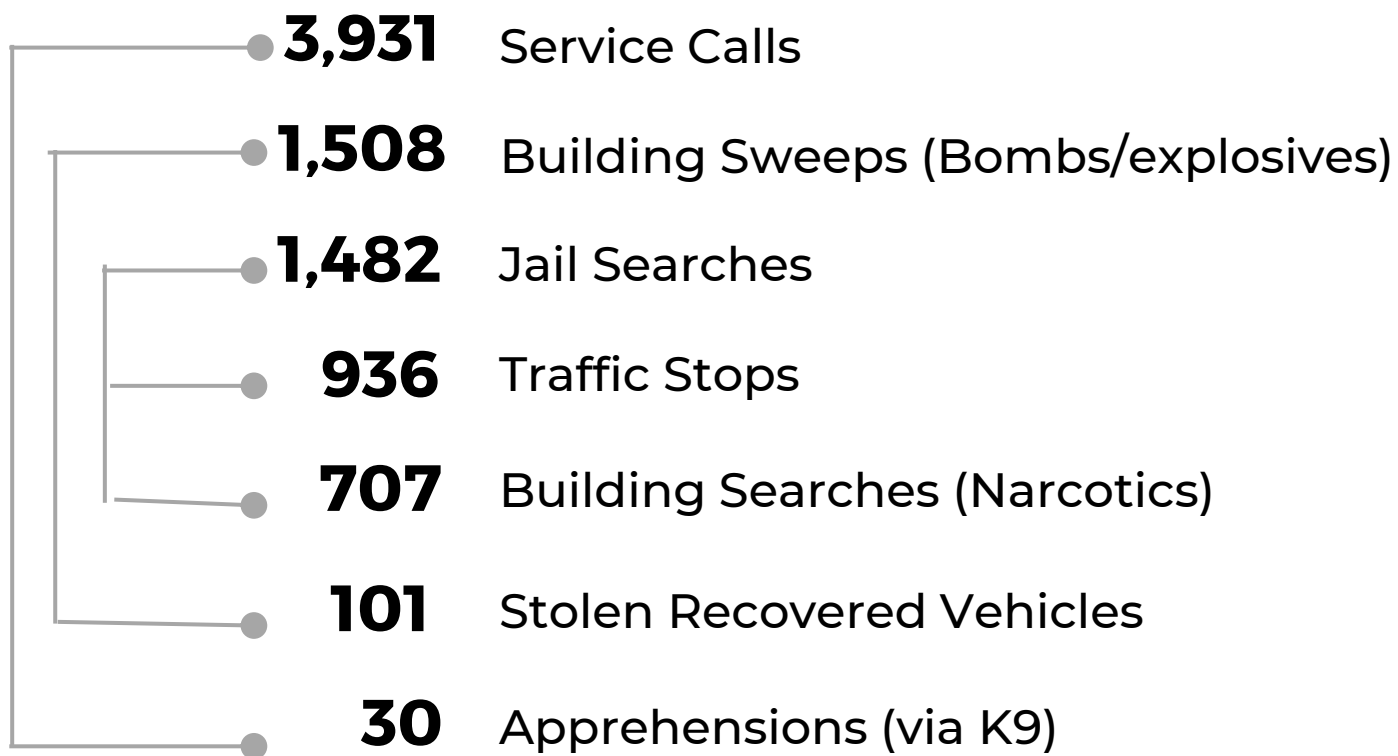


# LAW ENFORCEMENT - K-9 UNIT

## Key Stats and Highlights



- Since January 2021, the unit grew from 4 to 8 K-9s - 4 Explosive Ordinance Detection K-9s (EOD), 4 Narcotics K-9s
- 7 of the K-9 are dual purpose (4 Narcotics and Apprehension, 2 EOD and Apprehension, 1 EOD and Tracking), 1 is single purpose EOD
- Work with Local, State, and Federal agencies to assist with building searches, sweeps, tracking, and apprehension of suspects



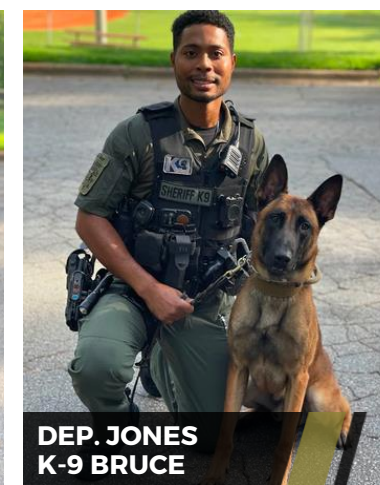
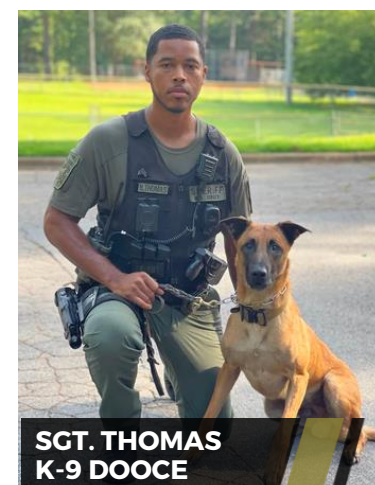
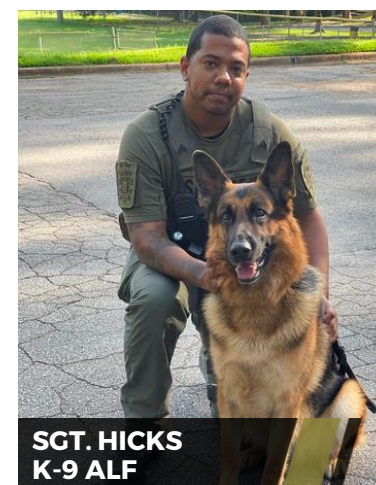
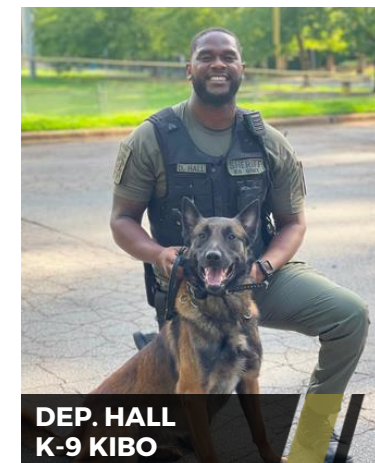
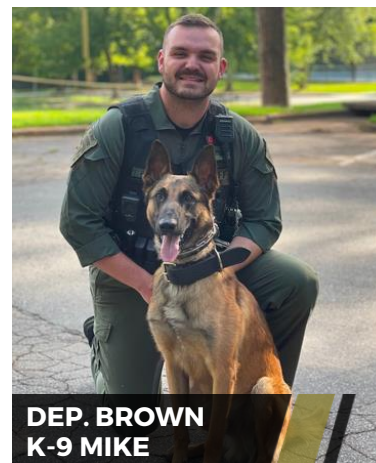
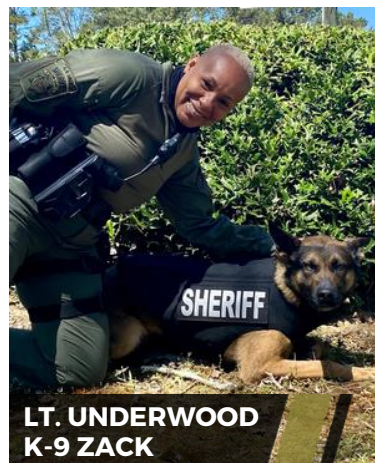

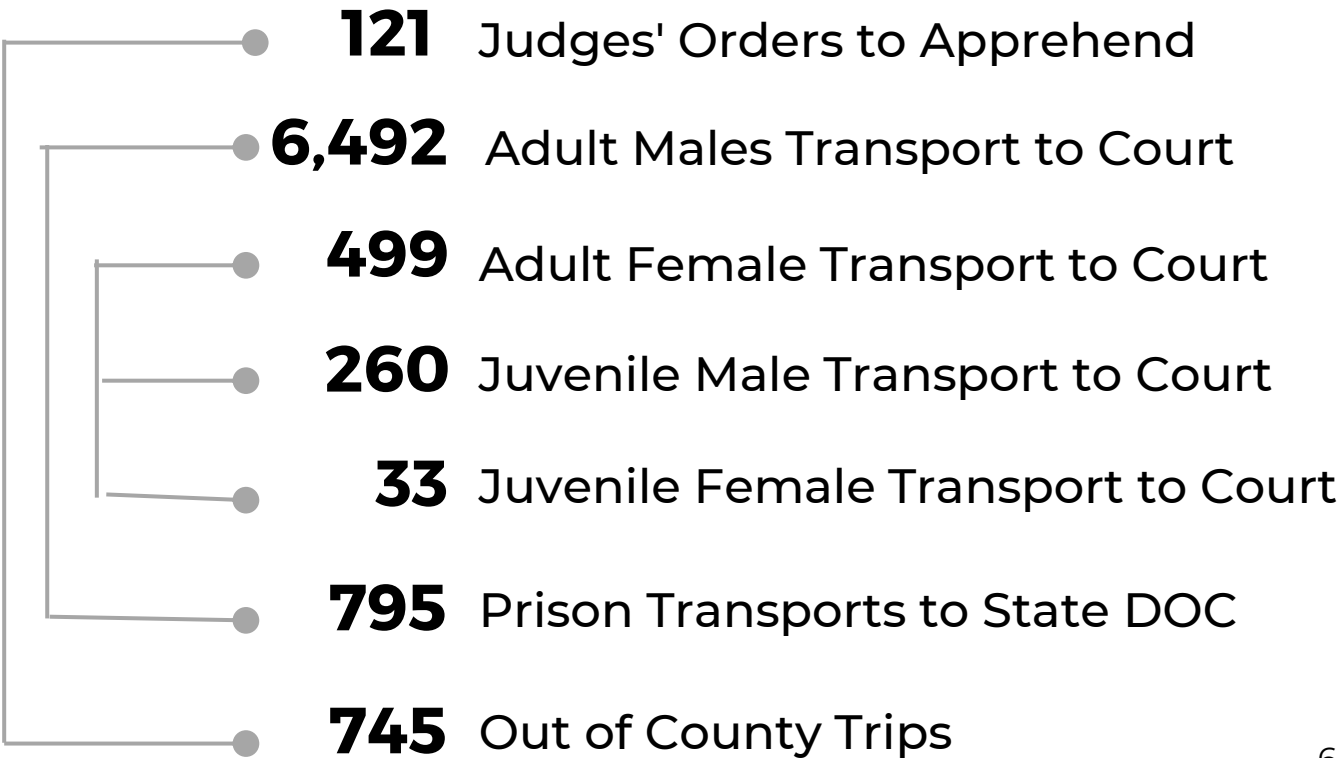


# LAW ENFORCEMENT - TRANSFER UNIT

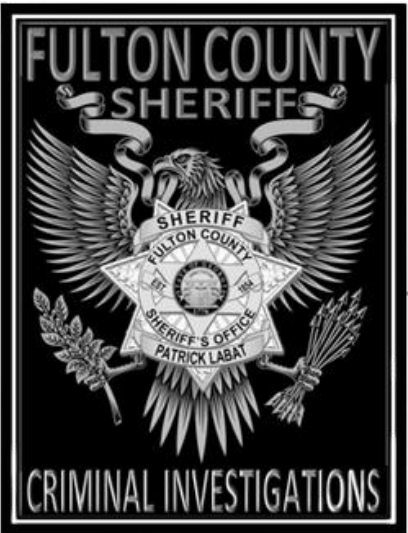

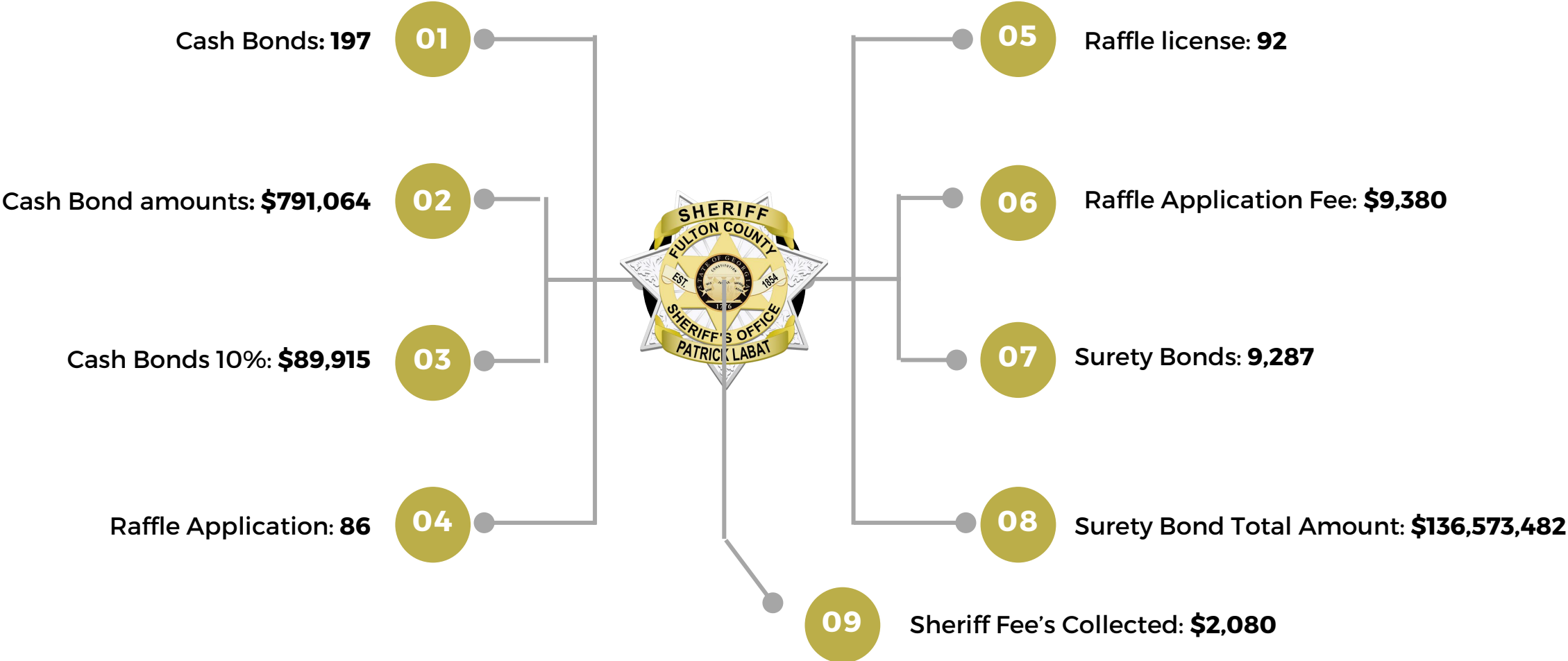

# FLEET

The Sheriff's Office fleet is currently comprised 316 vehicles, including Patrol Units, Administrative vehicles, Motors Units, Inmate Transfer Vans, K-9 Units, and other specialized vehicles. From fiscal year 2021 to date, we have replaced 32 vehicles per County Policy and have acquired 116 new vehicles.







# FLEET

Vehicles in inventory that currently meet Fulton County Policy and Procedure 400-6 Replacement and Retainment for County Vehicles/Equipment:

- Pursuit/Emergency Vehicles: 85 two years or older / 10 with 100,000 miles or more.
- Non-Pursuit/Emergency Vehicles: 52 three years or older / 26 with 100,000 mile or more.
- Currently there are 28 vehicles with Risk Management that are awaiting appraisal and or repairs.

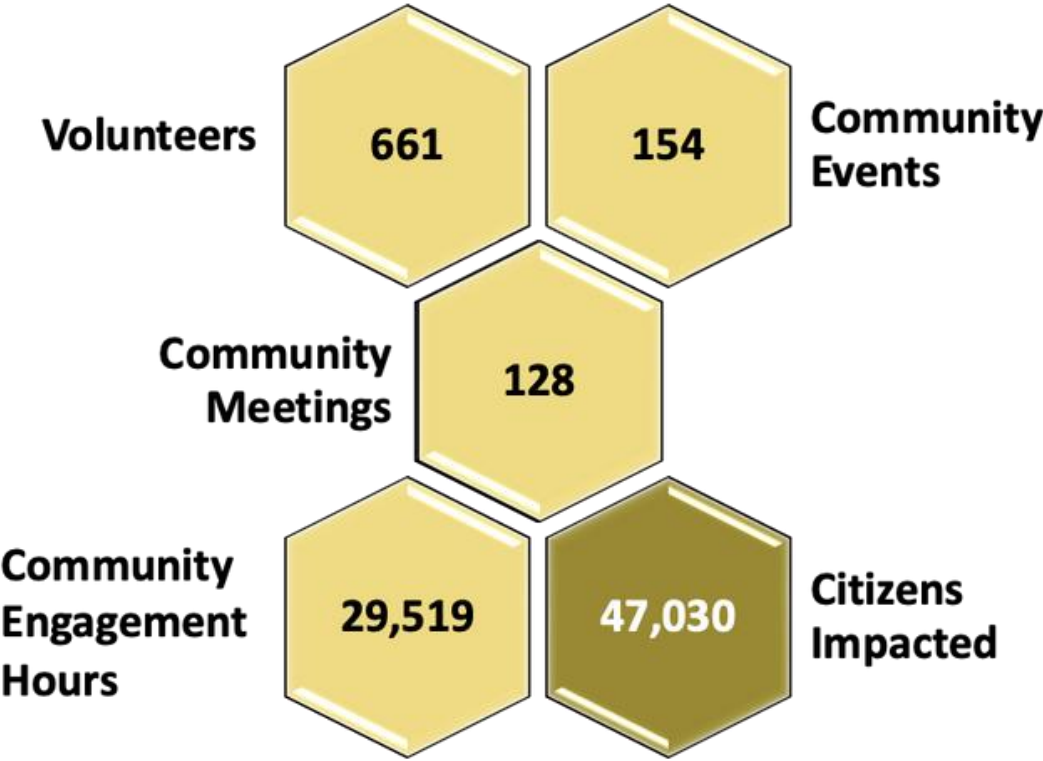
The average cost to install emergency equipment (lights, siren, and radio) into an Agency vehicle is \$18,111.75.

We held our first annual Back-to-School where we **serviced 600 families**. We also partnered with Atlanta Public Schools (APS), Fulton County Schools (FCS), Commissioner Arrington and Councilwoman Willis to impact over **15,000 students within Fulton County**.



## Junior Deputy Leadership Academy 2022

We hosted our annual Junior Deputy Leadership Academy where we provided a platform for **15 young adults** to learn day-to-day operations of actual law enforcement activities and a variety of real-world skills such as: Character building, civic responsibilities, and effective leadership skills.



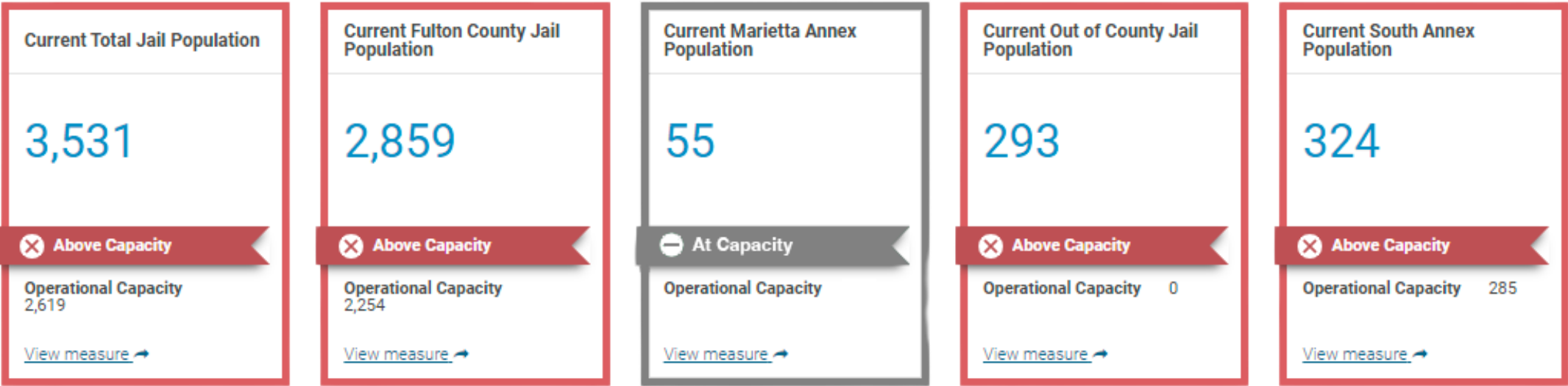




# JAIL POPULATION BY LOCATION

Current Jail Population *(updated daily)*



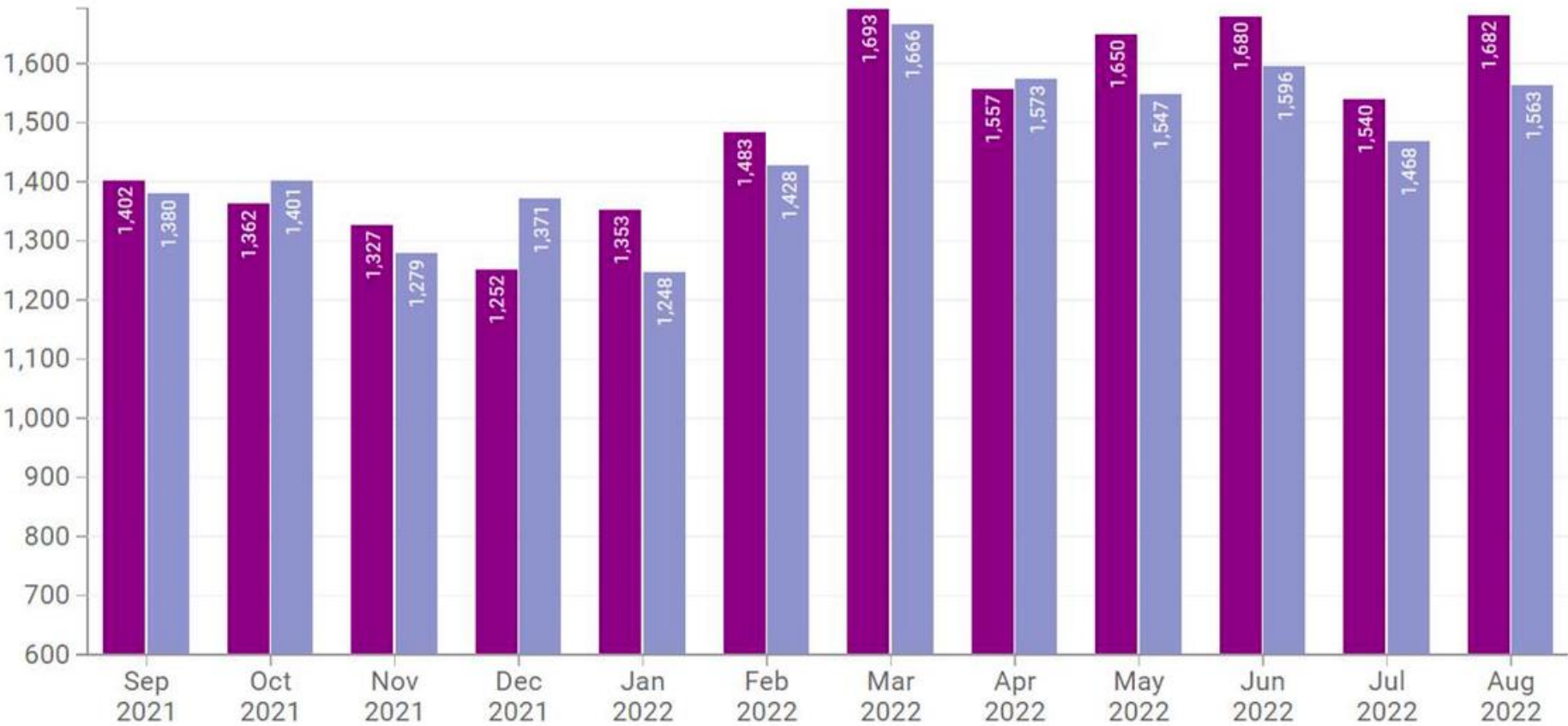

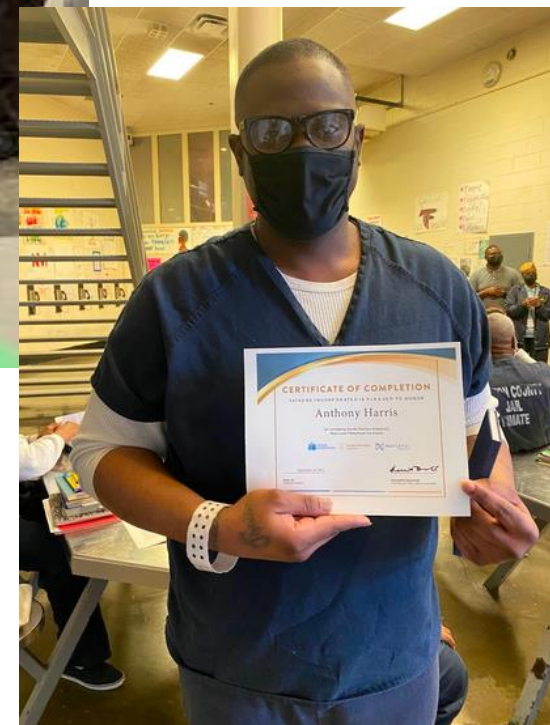

Provides Programs that help to reduce recidivism and equip inmates with valuable life skills upon release

## Spotlight Programs

**GED Program,** The GED Program prepares and tests inmates for competency in the main subjects taught during secondary school.

**Cosmetology Program,** This is an 8 week program for female inmates which uses varies cosmetology tools.

**New Beginnings Program,** This program targets males that focuses on anger and stress management, which helps them channel their anger and conflict in a positive manner by using different methods and techniques.
