11 WHEREAS, Fulton County, Georgia ("County") is a political subdivision of the 12 State of Georgia with the authority to enter into agreements to fulfill certain public

WHEREAS, the Building Authority of Fulton County ("Authority") is a body corporate and politic, duly created and existing as an instrumentality of the State of Georgia and a public corporation under the County Building Authorities Act, Ga. Laws 17 1980, p. 4488 *et seq.*, as amended; and

WHEREAS, the Authority was created for the purpose of providing buildings, facilities, and improvements for various departments, boards, commissions and agencies located in Fulton County, by financing, in whole or in part, the construction of such buildings, facilities, and improvements; and
