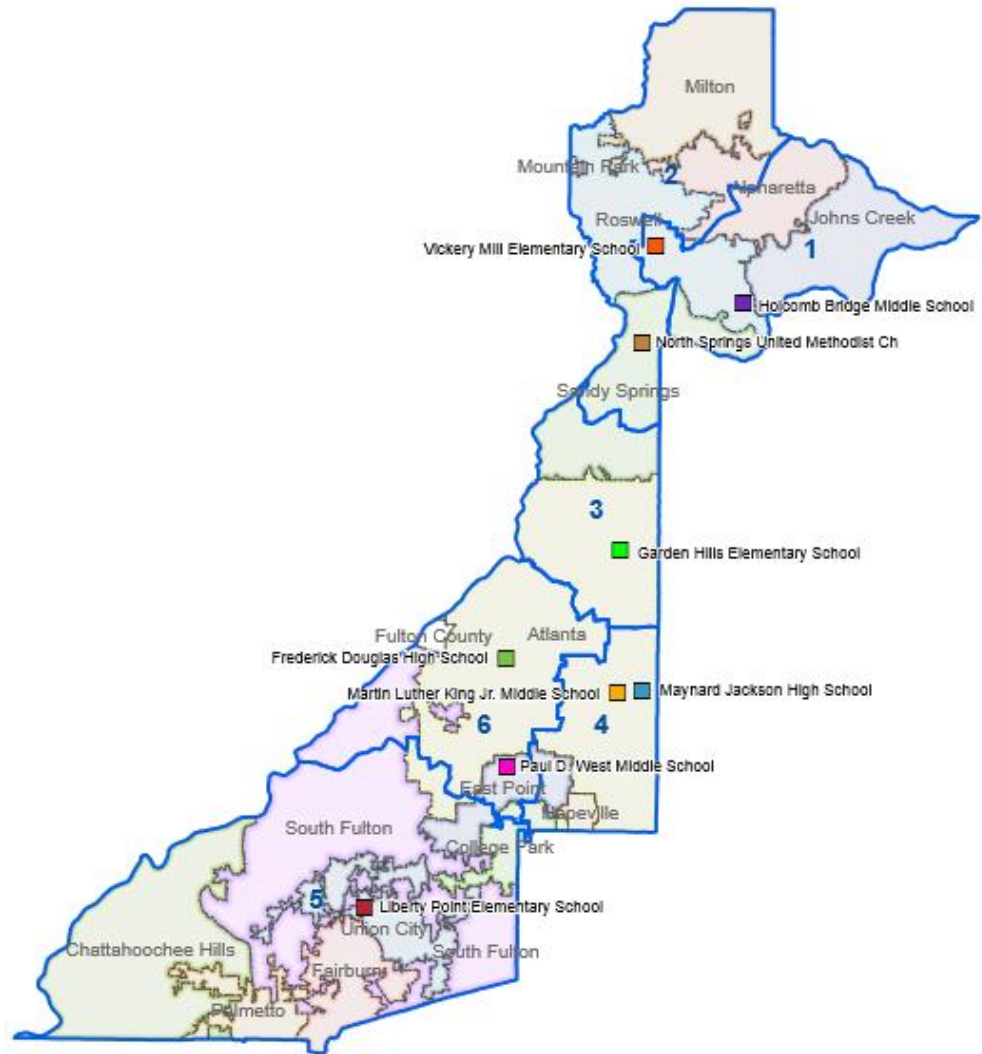

- We have secured assistance from the Fulton County Police Department to transport Election Night Memory Cards from our nine Election Night Check-In locations to expedite this process



# PREPARATION FOR HAND RECOUNT & RUNOFF

A Risk Limiting Audit / Hand Recount shall be selected by the Secretary of State for the November 8, 2022 General Election. The contest to be audited shall be selected by the Secretary of State and shall be publicly announced between Nov 9<sup>th</sup> to Nov 15<sup>th</sup>

Start Date: **November 17<sup>th</sup>**

Deadline for completion: **November 22<sup>nd</sup> 5pm**

We have secured the *Georgia International Convention Center* to conduct the RLA and are currently recruiting poll workers to assist with this process

Simultaneously, we will prepare for the **December 6, 2022 Runoff Election** if necessary

Pursuant to SEB Rule 183-1-15-.04, a Risk Limiting Audit shall be selected by the Secretary of State for the November 8, 2022 General Election. The contest to be audited shall be selected by the Secretary of State and shall be publicly announced and published on the Secretary of State webpage. Please be advised Fulton County ballots to be counted as part of this audit, shall be open to the public and will take place at the following location, dates, and hours. Fulton County Registration & Elections is seeking poll workers interested in assisting with this process.

THE RLA WILL END WHEN COMPLETED.**

Please be advised acknowledgment of the following guidelines must be signed for a possible work assignment:

- The RLA start date is November 17th and will stop when completed; therefore, all dates and shifts may not be required.
- Registering for a shift does not guarantee assignment.
- You must agree to receive text messages regarding the RLA shift assignments.
- Text messages regarding shift assignments will be sent the day prior for an 8 a.m. shift and/or 2 hours prior to the 3 p.m. shift.
- Only completely CLEAR SEE THRU transparent purses and/or bags are permitted inside the RLA Workspace.
- Signage of oaths will be required.
- Training will be conducted on site.
- No weapons allowed.
- Parking will be provided.
- No cell phone use is permitted inside the RLA workspace.
- No walk-ins will be accepted. If you appear without confirmation of assignment, you will not be permitted to work and will not be paid.
- Name badges will be provided and must be worn at all times.
- Only red pens are allowed in the RLA workspace.
- You must work the entire assigned shift in order to be paid.
- Payment per completed shift is two hundred dollars (\$200.00).
- A snack will be provided at each shift. If you have dietary restrictions, please plan to bring your own provisions. There will be no refrigeration provided.
- The entire event will be live streamed.
