A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN FULTON COUNTY, GEORGIA AND THE CITY OF UNION CITY FOR THE PURPOSE OF ALLOWING THE DEPARTMENT OF SENIOR SERVICES TO UTILIZE CITY-OWNED PROPERTY LOCATED AT 5285 LAKESIDE DRIVE, UNION CITY, GEORGIA FOR THE PROVISION OF CONGREGATE MEALS AND OTHER SENIOR SERVICES; TO AUTHORIZE THE CHAIRMAN TO SIGN THE INTERGOVERNMENTAL AGREEMENT AND ANY RELATED DOCUMENTS TO IMPLEMENT THE SAME; TO AUTHORIZE THE COUNTY ATTORNEY TO APPROVE THE INTERGOVERNMENTAL AGREEMENT AND ANY RELATED DOCUMENTS AS TO FORM AND MAKE NECESSARY MODIFICATIONS TO PROTECT THE COUNTY'S INTEREST; AND FOR OTHER PURPOSES

WHEREAS, Fulton County, Georgia ("Fulton County") is a political subdivision of the State of Georgia, existing as such under and by the Constitution, statutes, and laws of the State; and

WHEREAS, the Fulton County Department of Aging and Youth Services operates senior centers, including Neighborhood Senior Centers and Senior Multipurpose Facilities, throughout Fulton County offering a wide array of programming for older adults; and

WHEREAS, the Fulton County Board of Commissioners, on December 6, 2017 as Agenda Item No. 17-0980, previously approved an Intergovernmental Agreement, which has since expired, with the City of Union City to utilize the Etris Community Center, located at 5285 Lakeside Drive, Union City, Georgia, so as to allow Fulton County to provide congregate meals and other senior services to Fulton County seniors; and

WHEREAS, approval of an Intergovernmental Agreement is required for the Fulton County Department of Senior Services' continued utilization of the current centralized and easily accessible location from within the community; and

WHEREAS, the Fulton County Department of Real Estate and Asset Management and the Department of Senior Services have negotiated mutually acceptable terms for

Fulton County's occupancy at this location for a period of five (5) years, inclusive of renewal options; and

WHEREAS, Article 9, § 3, ¶ I of the Georgia Constitution provides that the County may contract for any period not exceeding 50 years with any other public agency, public corporation, or public authority for joint services, for the provision of services, or for the joint or separate use of facilities or equipment.

NOW THEREFORE BE IT RESOLVED, that the Board of Commissioners of Fulton County hereby approves of the execution of an Intergovernmental Agreement between the City of Union City and Fulton County in substantially the form attached hereto as Exhibit "A."

BE IT FURTHER RESOLVED, that the Chairman of the Board of Commissioners is hereby authorized to execute the Intergovernmental Agreement and any related document between Fulton County and the City of Union City.

BE IT FURTHER RESOLVED, that the County Attorney is hereby authorized to approve the Intergovernmental Agreement and any related documents as to form and to make such modifications as are necessary to protect the County's interests prior to execution by the Chairman.

BE IT FURTHER RESOLVED, that this Resolution shall become effective upon its adoption, and that all resolutions and parts of resolutions in conflict with this Resolution are hereby repealed to the extent of the conflict
