Please accept our proposal for the excavation, glove bag insulation and disposal of approximately 800 LF of friable asbestos insulated pipe. Because asbestos removal with have to completed by workers in full PPE we believe the production will be significantly decreased due to the heat and humidity.

Means & Methods

With the pipe being a depth between 2'-4' excavator will dig down on the sides of the pipe. Excavator will then remove as much of the dirt covering the top of the pipe. Asbestos workers will expose the pipe and glove bag the insulation leaving the pipe and properly disposing of the material.

Price of Work
