A RESOLUTION TO IDENTIFY POSITIONS TO BE USED FOR APPOINTMENT OF 1 FULTON COUNTY'S REPRESENTATIVES TO THE REGION 3 EMERGENCY 2 MEDICAL SERVICES ADVISORY COUNCIL; AND FOR OTHER PURPOSES 3 4 WHEREAS, Fulton County, Georgia ("Fulton County") is a political subdivision of 5 the State of Georgia, existing as such under and by the Constitution, statutes, and laws 6 7 of the State; and **WHEREAS**, Fulton County is interested in the promoting the safety and health of 8 Fulton County residents; and 9 **WHEREAS**, Fulton County promotes and participates in the Region 3 Emergency 10 11 Medical Services Advisory Council to coordinate and promote cooperation of emergency medical services within Fulton County and surrounding areas; and 12 WHEREAS, the Region 3 Emergency Medical Services Advisory Council serves 13 as the local coordinating entity for emergency response zones within Region 3; and 14 WHEREAS, the Region 3 Emergency Medical Services Advisory Council serves 15 as a liaison between the Georgia Department of Public Health and the emergency 16 medical services systems of Clayton, Cobb, DeKalb, Douglas, Fulton, Gwinnett, Newton, 17 and Rockdale counties; and 18 WHEREAS, the Region 3 Emergency Medical Services Advisory Council 19 promotes public education, knowledge and training relating to emergency medical 20 services at the local and regional level to persons involved with the delivery of emergency 21 22 medical services; and

WHEREAS, Fulton County, as a participant in the Region 3 Emergency Medical
Services Advisory Council is responsible for nominating and appointing six (6) members
of the Council; and

WHEREAS, Fulton County believes that certain persons in responsible positions 1 within Fulton County are the most knowledgeable and most qualified individuals to act as 2 members of the Region 3 Emergency Medical Services Advisory Council. 3 **NOW, THEREFORE, BE IT RESOLVED**, that the Board of Commissioners hereby 4 agrees that individuals holding the following positions are the most gualified to participate 5 in the Region 3 Emergency Medical Services Advisory Council: 6 1. The Chief of a Fire Department from one of the municipalities in the northern 7 portion of Fulton County as recommended by the majority of Fire Chiefs in the 8 9 northern portion of Fulton County; 2. The Chief of a Fire Department from one of the municipalities in the southern 10 portion of Fulton County as recommended by the majority of Fire Chiefs in the 11 southern portion of Fulton County; 12 3. The Chief of the City of Atlanta Fire Department; 13 4. The Board of Health District Health Director or his/her or their designee; 14 5. The Director of the Atlanta Fulton County Emergency Management Agency; 15 6. The Director of Fulton County's 911/E911 Department. 16 17 **BE IT FURTHER RESOLVED**, as opportunities to appoint members to the Region 3 Emergency Medical Services Advisory Council arise, the Board of Commissioners shall 18 nominate and appoint one person from each of the above categories to the Region 3 19 20 Emergency Medical Services Advisory Council; **BE IT FINALLY RESOLVED**, that going forward, the Fulton County Board of 21

continually serve on the Region 3 Emergency Medical Services Advisory Council.
