








Vaccination Response

<u>Current Vaccination</u> Deployment Posture

- 3 Fixed locations (combined capacity 200 Vax per day): 141 Pryor St. 4700 North Point Pw. 5710 Stonewall Tell Rd.
- 10 Mobile Units (combined capacity 750 Vax per day) = 50 events a week
- 3 Roving Strike Teams Conducting vaccine outreach & vaccine delivery in the lowest census tract communities



<u>*October 1st Vaccination</u> Deployment Posture

- 4 Fixed locations (combined capacity up-to 900 Vax per day, as demand dictates): 141 Pryor St. 4700 North Point Pw. 5710 Stonewall Tell Rd. 3900 Aviation Cir (Opens 6 October)
- 4 Mobile Units (combined capacity 300 Vax per day) = 20 events a week

*Shift back to more capacity at fixed sights for Booster Delivery & planned expansion to 5 and over populations.

All sites will continue to prioritize 1st and 2nd doses at all locations.

Area Command is continuing to look a ways to incentivise the unvaccinated !

Got second shot of Pfizer COVID-19 vaccine at least 6 months ago



Meet CDC Approved Criteria:

Recommended

- Age 65+ & residents in long-term care settings
- Age 50–64 with underlying medical conditions

May receive based on individual benefits and risks

- Age 18–49 with underlying medical conditions
- Age 18-64 at increased risk for COVID-19 exposure due to occupational or institutional setting

Emergency Rental Assistance Phase II Snapshot

KEY HIGHLIGHTS

- Fulton County FULLY EXPENDED \$18M ERA I funds
- Launched Phase II on August 2
 - Expending at a pace of \$1.1M per week
 - Expect to exhaust all ERA II funds on hand by mid-October
- Recognized as a "high-performing jurisdiction" per the US Treasury, and well positioned to receive additional funding due to recapture of funds from under-performing jurisdictions

Mortgage Assistance Update State of Georgia Administered

Georgia Homeowner Assistance Fund

Background:

US Treasury Department allocated \$9.9 billion to states and territories through the American Rescue Plan Act of 2021. Georgia's allocation was \$354M. The Department of Community Affairs (DCA) will administer the **State of Georgia Homeowner Assistance Fund**.

Key Points

State of Georgia Homeowner Assistance Fund

- The Homeowner Assistance Fund (HAF) program was established to mitigate financial hardships associated with the coronavirus pandemic by providing funds for the purpose of preventing homeowner mortgage delinquencies, defaults, foreclosures, loss of utilities, and displacements of homeowners experiencing financial hardship after January 21, 2020.
- DCA will create an online application for individuals to apply to receive funding.
- Georgia's plan is due to Treasury by July 31, 2021. The program will be launched after approved by Treasury.

Mortgage Assistance Update State of Georgia Administered

Below Statement From

State of Georgia Division Director for Housing

- Georgia submitted its Homeowners Assistance Fund Plan (HAF Plan) for Treasury approval in mid-August and they are still waiting to hear back.
- So far, Treasury has not approved any HAF Plan submissions from the states, but Georgia is hopeful this will happen soon.
- In the interim, DCA has established a pilot program that allows us to receive applications and fund homeowner needs for certain loans in our existing portfolio of GA Dream loans.
