8 9	WHEREAS, on December 17, 1997, the Fulton County Board of Commissioners	
10	enacted Policy and Procedure # 600-57, for the purpose of naming public facilities within	
11	Fulton County; and	
12	WHEREAS, on July 1, 2009, by way of Agenda Item # 09-0630, and in accordance	
13	with Policy and Procedure # 600-57, the Board of Commissioners established the Publi	
14	Facility Naming Advisory Board, which is known as the "Naming Commission;" and	
15	WHEREAS, the purpose of the Naming Commission is to consider requests and	
16	provide recommendations to the Board of Commissioners for naming or renaming publi	
17	facilities, structures, or other Fulton County resources, but excluding roads; and	
18	WHEREAS, the Lewis R. Slaton Courthouse ("Courthouse") is owned and operate	
19	by Fulton County and is located at 136 Pryor Street Southwest, Atlanta, GA 30303; and	
20	WHEREAS, Courtroom 9G in this Courthouse is an historic courtroom, as it has	
21	housed most of the previous Chief Judges of the Superior Court for Fulton County	
22	including the trailblazing Judge Clarence Cooper who co-integrated Emory University	
23	School of Law with the Honorable Marvin S. Arrington, Sr., reached many milestones in	
24	Fulton County, and went on to serve as a historic figure in federal court; and	
25	WHEREAS, the Probate Court will relocate courtrooms and chambers from	
26	Courtroom 2B to Courtroom 9G in the Courthouse; and	
27	WHEREAS, Judge Clarence Cooper, retired, is a graduate of Clark Atlanta	
28	University, Emory University School of Law, Harvard University, and Massachusetts

Institute of Technology; and

1	WHEREAS, Judge Clarence Cooper has served the United States of America in		
2	both the military and justice system, serving in the United States Army from 1968 to 1970,		
3	where he received the Bronze Star, a Certificate of Commendation, the National Defense		
4	Service Medal, the Army Good Conduct Medal, the Vietnam Service Medal, and the		
5	Vietnam Campaign Medal; and		
6	WHEREAS, Judge Clarence Cooper is a trailblazer and has had a long and		
7	distinguished career in the United States justice system, working as an attorney with the		
8	Atlanta Legal Aid Society and then becoming the first African-American Assistant District		
9	Attorney in the State of Georgia in 1968, where he worked for the Fulton County District		
10	Attorney's Office in 1968 and from 1970 to 1975; and		
11	WHEREAS, Judge Clarence Cooper began his service as a judge on the City of		
12	Atlanta Municipal Court in 1975, where he was the first African-American appointed to a		
13	full-time judgeship; and		
14	WHEREAS, Judge Clarence Cooper was the first African-American ever elected to		
15	a county-wide judgeship on the Fulton County Superior Court, where he served from 1980		
16	to 1990; and		
17	WHEREAS, Judge Clarence Cooper served as a Justice on the Georgia Court of		
18	Appeals from 1990 to 1994, and was nominated by President Bill Clinton to become a		
19	United States District Judge of the United States District Court for the Northern District of		
20	Georgia on March 9, 1994; and		
21	WHEREAS, the United States Senate confirmed Judge Cooper for his seat on the		
22	United States District Court for the Northern District of Georgia on May 9, 1994, where he		
23	continues to serve until he took Inactive Senior status in September of 2021; and		
24	WHEREAS, the Naming Commission convened to discuss the naming of Courtroom		

9G for the Honorable Clarence Cooper, and voted to recommend to the Board of

- 1 Commissioners the naming of Courtroom 9G in the Courthouse as the "Honorable
- 2 Clarence Cooper Courtroom" to honor Judge Cooper and to recognize his tremendous
- 3 contributions to the United States judicial system and society as a whole; and
- 4 **WHEREAS**, the Naming Commission has selected and is recommending that the
- 5 Board of Commissioners name Courtroom 9G in the Courthouse as the "Honorable
- 6 Clarence Cooper Courtroom".
- 7 **NOW, THEREFORE, BE IT RESOLVED** that the Board of Commissioners hereby
- 8 accepts the recommendation from the Naming Commission and hereby dedicates and
- 9 names Courtroom 9G in the Lewis R. Slaton Courthouse as the "Honorable Clarence
- 10 Cooper Courtroom"; as an honor befitting a judge who served Fulton County and its
- 11 citizens with distinction.
- 12 **BE IT FURTHER RESOLVED**, that the County Manager is hereby authorized to
- take all necessary steps to effectuate the naming of Courtroom 9G as provided herein, and
- that the Chairman and County Manager are hereby authorized to execute all necessary
- documents to effectuate the naming of the courtroom.
- 16 **BE IT FURTHER RESOLVED,** that the Department of Real Estate and Asset
- 17 Management shall create appropriate signage to be placed in and around Courtroom 9G
- designating it as the "Honorable Clarence Cooper Courtroom".
- 19 **BE IT FINALLY RESOLVED**, that this Resolution shall become effective when
- 20 adopted, and that all resolutions and parts of resolutions in conflict with this Resolution are
- 21 hereby repealed to the extent of the conflict.
