1. Describe what efforts were made to reduce the scope and cost of this contract.

The contract provides In-home services to senior age 60 and above. Services include homemaker, personal care, and respite care. Currently the waiting list exists for homemaker (169), personal care (142) and respite (14). Staff manages the waiting list to ensure that the contractors stay within their budgets and that only those seniors requesting services that are most in need are placed in service. Although, the country was experiencing COVID-19 services were delivered, but not at optimal levels. The Department did provide a proposal to expand the number of contractors, which was approved. This brought the number of contractors from 2 to 4.

### **Explanation / Notes:**

According to the "Cost of Care Survey", an annual report by Genworth, home care costs less than other options like adult day care, assisted living and skilled nursing. In fact, the national average cost of home care per hour is \$24 per hour, but again this can vary depending on the type of care you need and your geography. Genworth also reports that the cost of home care services increased by 79.17%% Since 2004. Nationally, the range is from \$17.00 to \$33.00.

The Survey Showed That The Most Expensive States As Far As Senior In-Home Care Is Concerned Include (Average Costs):

Senior Home Care: \$15 - \$25 per hour for hourly care and \$150 - \$350 per day for 24-hour live-in care. Assisted Living Community: \$4,000 per month + additional fees for meals, special services and activities + additional cost for private duty caregiver services (see Senior Home Care costs above).

Although the national median cost of receiving care rose considerably across all care options during the last 12 months, the increase was most pronounced for home health aides: 2017

Home health aide services, up 11.4% to \$24.00/hour

Homemaker services, up 4.75% to \$21/hour

Adult day health care services, up 2.94% to \$70/day

Assisted living facilities, up 3.36% to \$123/day or \$3,750/month

Semi-private room nursing home care, up 4.44% to \$235/day or \$7,148/month

Private room nursing home care, up 5.50% to \$267/day or \$8,121/mon

By comparison, the average resident at an assisted living community pays \$3628 per month. Nursing homes can cost up to \$253 per day. In the past five years, the costs for assisted living and skilled nursing have risen by 3.5%.
