**Scope of Work:** The Department for HIV Elimination recommends amending an existing contract with The Networked Planet, LLC. to increase the spending authority by \$11,327.00. The Board of Commissioners previously approved a contract with The Networked Planet, LLC for development of a website and ongoing maintenance of the website. This request is to increase funds available for website maintenance in GY2024 to \$19,237.00. Additional funding will support full website documentation, improve accessibility for all users, and connect website to newly launched social media accounts, and ongoing updates and plug-in renewals. The website serves as a tool to: increase transparency; provide information to clients, subrecipients and the general public; link citizens to services; share policies and procedures and grant requirements; and, provide information on the Metropolitan Atlanta HIV Health Services Planning Council.

**Community Impact:** The website will provide useful information to the public, subrecipients, and clients regarding programs and services administered by the Department for HIV Elimination.

**Department Recommendation:** The Department for HIV Elimination recommends Approval of modification of a contract with The Networked Planet, LLC to increase spending authority for website development and maintenance pursuant to the Ryan White Part A Program and the Ending the HIV Epidemic Funding for an amount not to exceed \$19,237 in Grant Year 2024.
