Scope of Work: The Marshal's Department is requesting approval to replace its 2012-2015 TASER model fleet of 60 X26 TASER CEW units (one for one trade-in) with the current TASER 7 model. The CEW (conducted-electrical weapon) deploys an electrical probe designed to temporarily incapacitate a person from a safer distance than some other use of force options and reduces the likelihood of death or serious injury. The Marshal's Department began initial purchase of TASER CEW units in 2012 to its current 60 unit inventory in 2015 - as annual budget allowances supported procurement at department level thresholds. The Marshal's Department, in its request to replace TASER CEW units, joins the Sheriff's Office in their business/service relationship with Axon Enterprise, Inc., for body worn cameras & TASER CEW components, approved by the Board of Commissioners on August 1, 2018, BOC Item 18-0518. This procurement has installments payments over a five (5) year period. The request is for installments for Year 1 and Year 2 at \$42,999.60. Subsequent years 3-5 will be presented to the BOC for approval for that FY. This procurement is pursuant to 102-384, when necessary to maintain compatibility with existing equipment or systems, only specified makes and models of technical equipment, software and parts will satisfy the county's needs for additional units or replacement items, and only one source is available.
