**Scope of Work**: Georgia Department of Transportation will be bidding the milling and resurfacing on this section of Roosevelt Highway at its intersection with Washington Road in its project. A Memorandum of Understanding (MOU) with the Georgia Department of Transportation has been proposed as the method of allowing the GDOT contractor to adjust the sewer manholes with appurtenances.

**Community Impact:** Currently sewer line has served facilities along Washington Road as a part of Fulton County South Fulton collection and conveyance system. The road milling and resurfacing will affect the elevation of the existing sewer manhole in this area.

**Department Recommendation:** The Fulton County Department of Public Works recommends executing the Memorandum of Understanding (MOU) with the Georgia Department of Transportation as the most cost effective way to complete these adjustments.

**Project Implications:** The road milling and resurfacing impacts the existing sewer manhole due to modifications of existing grades along the roadway which in turn requires structures to be adjusted to match the proposed roadway surface. The adjustment of sewer manholes must occur to maintain service in this area.

**Community Issues/Concerns:** During construction of the adjustment of sewer manholes & sewer services has to be maintained and service will not be impacted.

Department Issues/Concerns: The Department has no issues or concerns with the proposed MOU.
